

Commencing at the unmarked Northwest corner of the Southwest Quarter of Section #3, being in the road bed of Hunt Road (Township Road #294), also being a corner of Heather Hill Subdivision as recorded in Plat Book 14, Page 99; thence S 86 46 00 E 225.54 feet along the North line of the Southwest Quarter to the unmarked Northeast corner of Lot #16 of said Heather Hill Subdivision, passing an iron pin (found) at 25.57 feet; thence S 86 46 00 E 1120.78 feet continuing along the North line of said Southwest Quarter to an iron pin (found) at the Northwest corner of the Hidden Springs Farm Community property described in deed reference Deed Book Volume 810, Page 60, and the place of beginning for the property herein intended to be described, passing an iron pin (found) at the Southeast corner of a 2.97 acre parcel surveyed from the Richard and Lena Powell property in the Northwest Quarter of Section #3 at 10.92 feet;



- #2- thence S 42 29 40 W 316.32 feet along the Northwest line of said Jahnes property to an iron pipe (found) at the common corner of said Jahnes property and Lots #37 & #38 of said Heather Hill Subdivision, as monumented by a unrecorded resurvey of Heather Hill Subdivision completed by W. J. Biedenbach PLS #5718 in December 1981, passing an iron pin (found) on said Jahnes Northwest line at 0.41 feet:
