Commencing at the northeast corner of the northeast quarter of Section 15; thence along the north line of said Section 15 west a distance of 744.0 feet to a point; thence south 1 degrees 39 minutes east 1404.40 feet to a point in the center of Flint Ridge Road; thence along said centerline south 89 degrees 11 minutes west 245.0 feet to the true place of beginning of the premises herein intended to be described; thence continuing south 89 degrees 11 minutes west 155.0 feet to a point in the center of said road; thence leaving said road north 1 degree 39 minutes west 562.0 feet to a pin; thence north 89 degrees 11 minutes east 155.0 feet to an iron pin; thence south 1 degree 39 minutes east 562.0 feet to the true place of beginning, containing two (2.0) acres more or less.


