DESCRIPTION OF SURVEY FOR CHARLES A. MURREY

Situated in the State of Ohio, County of Muskingum, Township of Hopewell:

Being part of the Northwest Quarter of Section # 20, Township #1, Range #9, of the US Military District, also being part of a 66.113 acre parcel described in prior deed reference Volume 1051, Page 169 of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 25-25-35-20-05-000, and more particularly described as follows;

Beginning at an iron pin (found) at the intersection of the West line of said Section #20 and the extension of the center line of Murrey Drive, and West of the road bed for Sand Ridge Road (County Road #92) as recorded in Plat Book 16, Page 100;

#1- thence N 03 21 15 E 552.55 feet along the West line of said Section #20 to the Southwest corner of the Farm Supply Center, Inc. property as described in deed reference 988, Page 283, being within the road bed of Sand Ridge Road;

#2- thence S 58 39 45 E 328.87 feet along said Farm Supply Center, Inc. property to an iron pin (found) at a corner of said Farm Supply Center, Inc. property and for said 66.113 acre parcel, passing an iron pin (found) at 22.89 feet;

#3- thence S 88 33 05 E 174.92 feet continuing along said Farm Supply Center, Inc. property to an iron pin (set by previous survey) at the Northwest corner of a 5.49 acre parcel previously surveyed by Charles R. Harkness PLS #6885 and to date not recorded;

#4- thence S 12 24 40 W 529.64 feet along the West line of said 5.49 acre parcel to the center of said Murrey Drive, passing an iron pin (set by previous survey) at 504.39 feet;

#5- thence N 69 20 25 W 399.98 feet along the center of said Murrey Drive to the place of beginning, containing 5.03 acres.

The bearings within the description are based on iron pins (found) on Murrey Drive as recorded in Plat Book 16, Page 100. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).




