Situated in the State of Ohio, County of Ashland, Township of Hopewell, Southeast Quarter of Section 28, T11, R17, bounded and described as follows:

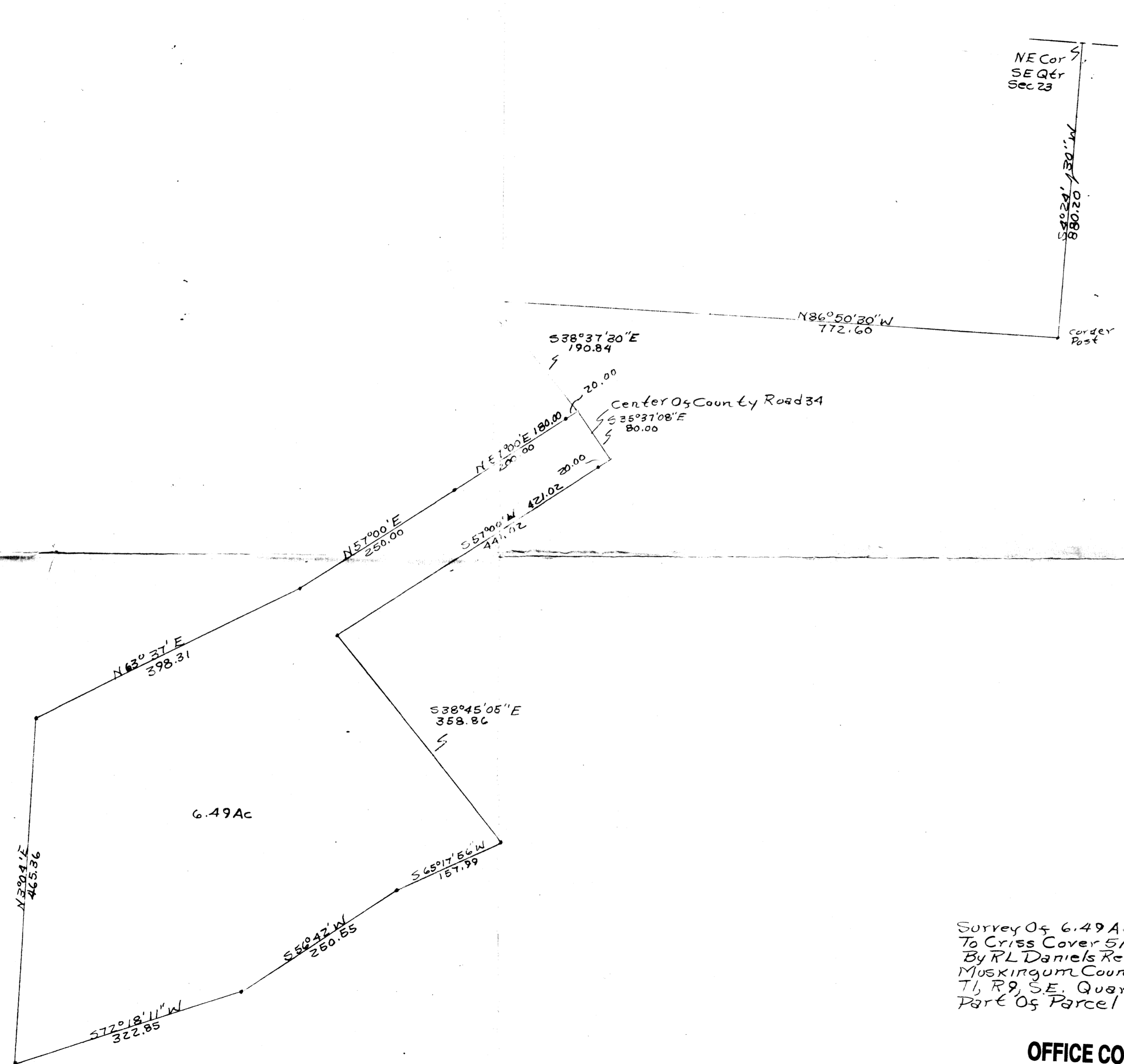

Bearings are based on the East line of the Northeast Quarter of Section 28 being South  $4^{\circ} 24' 30''$  West.

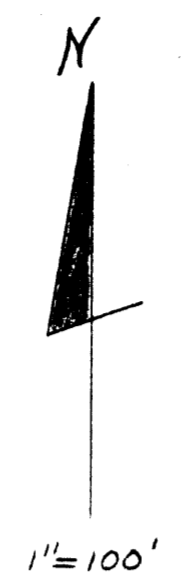
