LEGAL DESCRIPTION FOR T. SMITLEY

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF HOPEWELL, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 21, TOWNSHIP 1, RANGE 9 OF THE UNITED STATES MILITARY LANDS, AND BEING THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1088, PAGE 652.

COMMENCING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 21, THENCE, SOUTH 88 DEGREES - 30 MINUTES - 23 SECONDS WEST, 148.36 FEET TO AN IRON PIN FOUND IN TOWNSHIP ROAD 288 AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, ALONG SAID ROAD, THE FOLLOWING THREE (3) COURSES AND DISTANCES:

 SOUTH 29 DEGREES - 18 MINUTES - 43 SECONDS EAST, 146.56 FEET TO A POINT.
SOUTH 26 DEGREES - 16 MINUTES - 24 SECONDS EAST, 53.59 FEET TO A POINT.
SOUTH 14 DEGREES - 11 MINUTES - 40 SECONDS EAST, 62.98 FEET TO A POINT.

THENCE, SOUTH 89 DEGREES - 25 MINUTES - 42 SECONDS WEST, 235.88 FEET TO AN IRON PIN FOUND ON THE EAST LINE OF THOSE LANDS RECORDED IN DEED VOLUME 915, PAGE 65, PASSING AN IRON PIN FOUND AT 22.50 FEET; THENCE, NORTH 03 DEGREES - 12 MINUTES - 42 SECONDS WEST, 79.84 FEET TO AN IRON PIN SET; THENCE, NORTH 87 DEGREES - 57 MINUTES - 02 SECONDS EAST, 111.58 FEET TO THE NORTHEAST CORNER OF AN EXISTING BRICK BUILDING, SAID BUILDING FORMERLY REFERRED TO AS "THE BRICK CHURCH BUILDING"; THENCE, NORTH 02 DEGREES - 34 MINUTES - 52 SECONDS WEST, 155.07 FEET ALONG AN EXISTING IRON FENCE TO A POINT AT THE NORTHEAST CORNER OF THOSE LANDS RECORDED IN DEED VOLUME 431, PAGE 411; THENCE, NORTH 88 DEGREES - 30 MINUTES - 23 SECONDS EAST, 24.90 FEET TO THE PLACE OF BEGINNING AND CONTAINING 0.657 ACRES MORE OR LESS.
