Situated in the County of Muskingum, in the State of Ohio, and in the Township of Hopewell, and bounded and described as follows:

Being a part of the Northwest Quarter of Section 21, Township 1, Range 9 of the United States Military Lands, and being further described as follows:

Commencing at the center of Section 21; thence along the east line of the northwest quarter North 05 degrees 28 minutes 00 seconds East 153.70 feet to a point; thence leaving said quarter line and with the north line of a twenty-five foot wide ingress and egress easement North 85 degrees 30 minutes 00 seconds West, passing an iron pin set at 30.44 feet, a total distance of 198.57 feet to an iron pin set, said iron pin being the place of beginning of the tract herein intended to be described; thence continuing North 85 degrees 30 minutes 00 seconds West 155.00 feet to an iron pin set; thence leaving the north line of said easement North 05 degrees 19 minutes 32 seconds East 188.21 feet to an iron pin set on the north line of the grantor's tract, said iron pin being South 85 degrees 26 minutes 52 seconds East 8.65 feet from an existing iron pin (3/4 inch pipe); thence along the north line of the grantor's tract South 85 degrees 26 minutes 52 seconds East 155.00 feet to an iron pin set at the northwest corner of a 0.858 more or less acre tract; thence leaving said north line and with the west line of said 0.858 more or less acre tract South 05 degrees 19 minutes 32 seconds West 188.07 feet to the place of beginning, containing 0.669 more or less acres, SUBJECT TO all applicable easements. Being 10 ac. from parce 11 and .35 from parce 10 and an additional .219 from survey

All iron pins set are 5/8 inch x 30 inch rebar with plastic identification cap.

ALSO the following 25 foot ingress and egress easement: Being a part of the Northwest Quarter of Section 21, Township 1, Range 9 of the United States Military Lands, and being further described as follows:

Commencing at the center of Section 21; thence along the east line of the northwest quarter North 05 degrees 28 minutes 00 seconds East 128.70 feet to a point, said point being the place of beginning of the easement herein intended to be described; thence leaving said quarter line and with the south line of the grantor's tract North 85 degrees 30 minutes 00 seconds West, passing an existing iron pin (1 inch pipe) at 30.00 feet; a total distance of 353.52 feet to a point; thence leaving said south line North 05 degrees 19 minutes 32 seconds East 25.00 feet to an iron pin set at the southwest corner of a 0.669 more or less acre tract; thence along the south line of said tract and the south line of a 0.858 more or less acre tract South 85 degrees 30 minutes 00 seconds East, passing iron pins set at 155.00 feet and 323.13 feet, a total distance of 353.57 feet to a point on the east line of said northwest quarter; thence along said east line South 05 degrees 28 minutes 00 seconds West 25.00 feet to the place of beginning.
