parcel herein intended to be described; thence south 80 degrees 00  
minutes west along said centerline a distance of 200.00 feet to a  
point; thence north along the line of lands now or formerly owned by  
E. Paul and recorded in deed book 691, page 325 of the deed records  
of said county a distance of 279.85 feet to an iron pin and passing  
through an existing iron pin at 40.00 feet; thence north 80 degrees  
06 minutes east along said Paul line a distance of 199.94 feet to  
an iron pin; thence south along the westerly line of lands now or



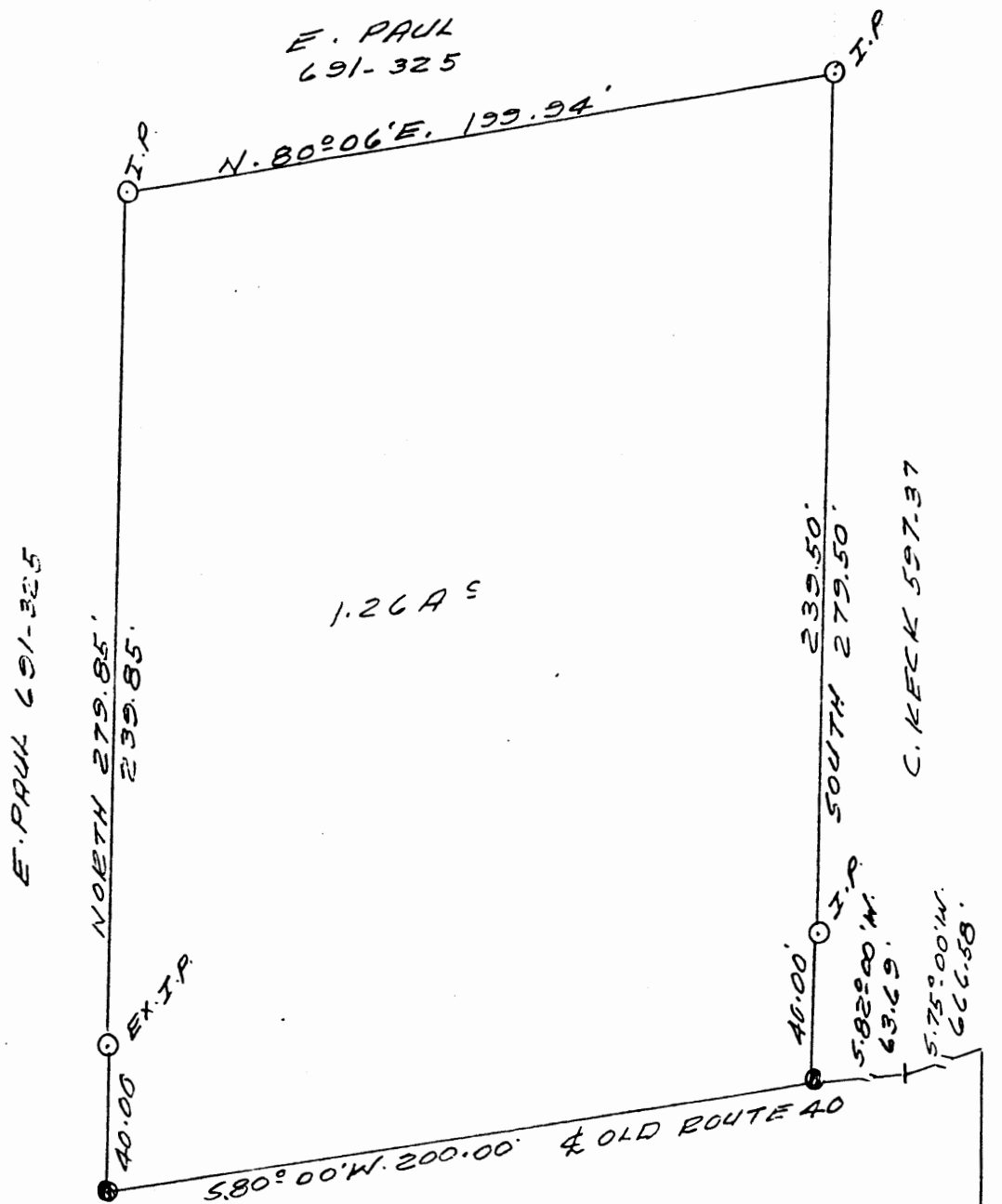
