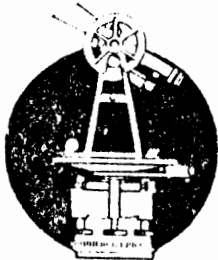

Situated in the State of Ohio, County of Muskingum, Township of Hopewell.

Being a part of Section 21 in Quarter Township 4, Township 1, Range 9 bounded and described as follows:

Commencing at a stone at the Northeast Corner of the Northwest Quarter of Section 21; thence ^{South} north 24 degrees 32 minutes ^{West} east 145.36 feet to a point in the center of Township Road #288; thence along said road south 19 degrees east 150 feet to a point in said road and the true place of beginning of the premises herein intended to be conveyed; thence north 85 degrees 16 minutes east 208.17 feet to a point; thence south 0 degrees 40 minutes west 154.08 feet to an iron pin; thence north 89 degrees 20 minutes west 170 feet to an iron pin in the center of Township Road #288; thence along said road north 0 degrees 40 minutes east 30.24 feet to an iron pin; thence continuing along said road north 19 degrees west 110.70 feet to the true place of beginning, containing sixty-two hundredths (0.62) of an acre more or less.

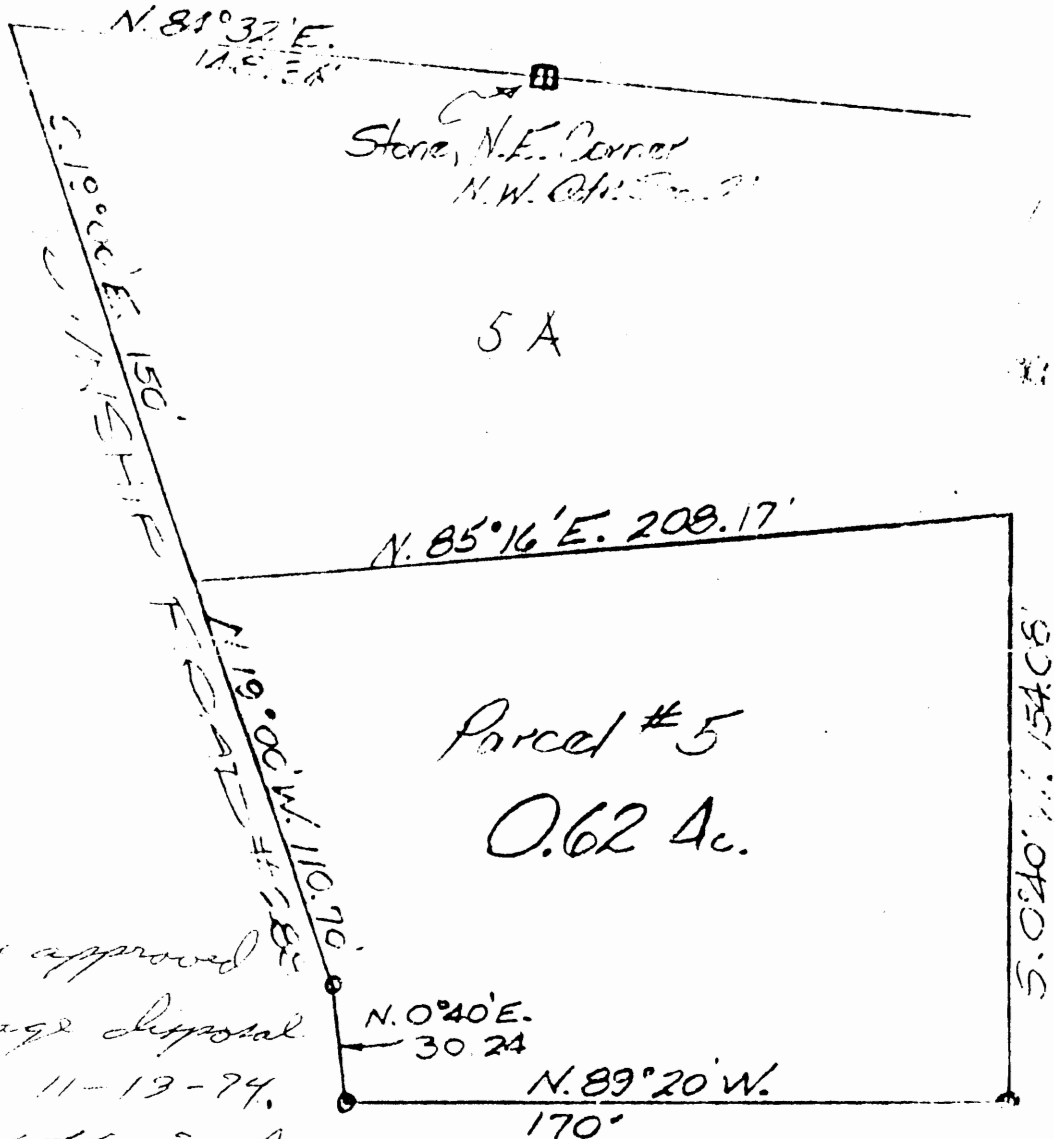
