7.456 acres

Being a resurvey of a parcel conveyed to Louise E. Bauer, as described and recorded in Deed Volume 932, Page 165, as found in the Office of the Recorder, Muskingum County, State of Ohio, and being more particularly described as follows.

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of Lot #34, and Lot #33, in the Third Quarter of Twp. 1, Rng. 9, United States Military Lands, and being more particularly described as follows.

BEGINNING, at a mag-nail set in the centerline of County Line Road as well as on the line dividing Licking and Muskingum County, marking the Southwest corner of Lot #34, ***N 05° 48' 30" E***, and following said centerline, **248.20** feet to a mag-nail set.

Thence, from said mag-nail set, ***S 83° 54' 30" E***, passing over an iron rebar set at 30.00 feet, a total distance of **750.70** feet to an iron rebar set on the East side of an unnamed creek.

Thence, from said iron rebar set, ***S 13° 48' 57" W***, **499.50** feet to an iron rebar found marked "Harkness #6885".

Thence, from said iron rebar found, ***N 80° 10' 20" W***, **81.45** feet to a point in said unnamed creek.

Thence, from said point ***N 75° 38' 30" W***, passing over an iron rebar set at 576.24 feet, a total distance of **606.60** feet a mag-nail set in the centerline of County Line Road, as well as the line between Licking and Muskingum County.

Thence, from said mag-nail set, and following said centerline and county line, ***N 05° 48' 30" E***, **154.25** feet to **THE TRUE PLACE OF BEGINNING.**

The above described tract contains **7.456 ACRES** more or less.

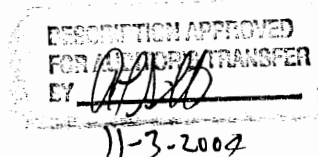
Bearings on the above description are based on the county line between Licking and Muskingum County, as being ***N 05° 48' 30" E***, and are used to denote angles only.
