Bearings are based on the South line of the Northeast Quarter of Section 1 bearing South $84^{\circ}42'00''$ East.

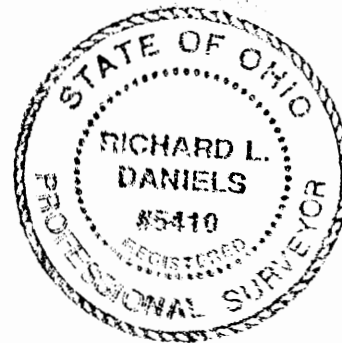

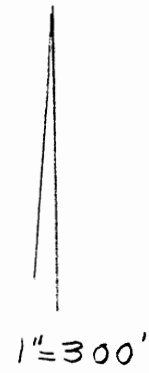
