Commencing at the Northeast corner of the Southeast Quarter of Section 1; thence South $7^{\circ} 27' 00''$ West 1253.56 feet to an iron pin found on the Northeast corner of Russell Bishop; thence South $7^{\circ} 27' 00''$ West 302.81 feet to a point, the place of beginning; thence South $7^{\circ} 27' 00''$ West 149.13 feet to a point, the Southeast corner of Russell Bishop; thence North $80^{\circ} 15' 10''$ West 292.09 feet to an iron pin set on the South line of Russell Bishop; thence North $7^{\circ} 27' 00''$ East 149.13 feet to an iron pin set; thence South $80^{\circ} 15' 10''$ East 292.09 feet to the place of beginning, passing an iron pin set at 247.90 feet, containing 1.00 acre more or less.

Bearings are based on the East line of the Southeast Quarter of Section 1 bearing South $7^{\circ} 27' 00''$ West.

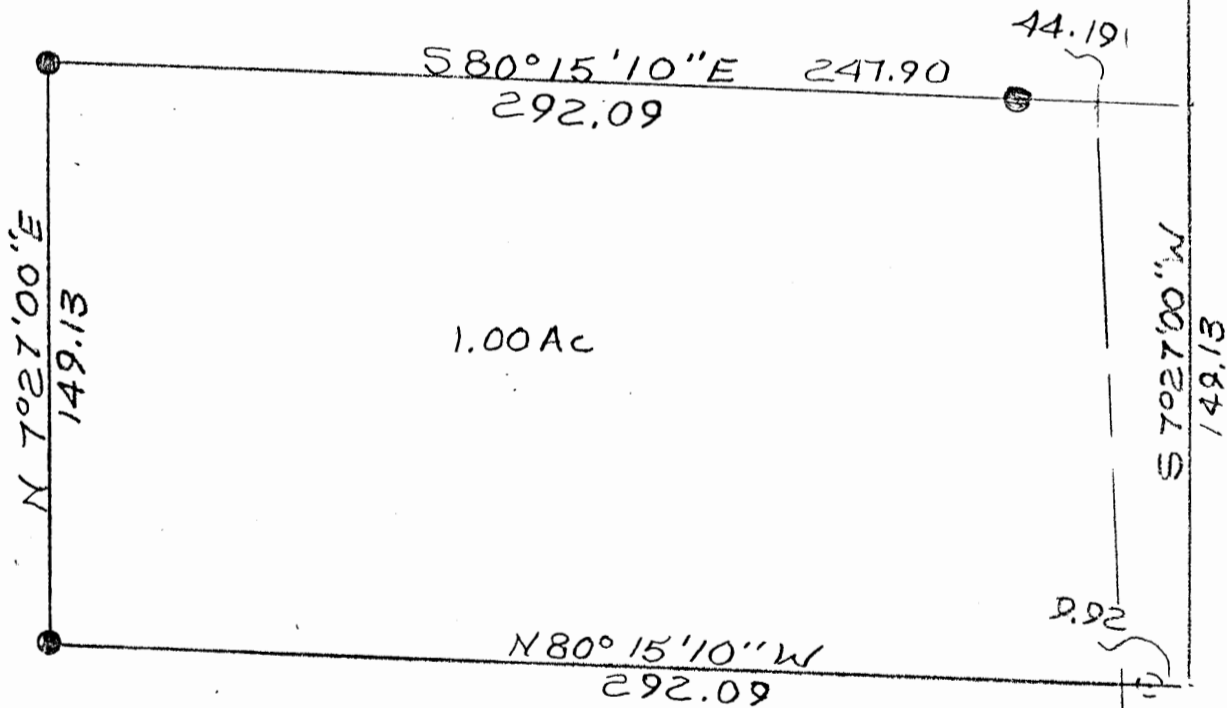
