- TIE-1 THENCE North 04 degrees 10 minutes 25 seconds East 1009.44 feet along the common line for said Sections #1 & #2 to an unmarked point being the common corner for the Michael S & Melissa Atkinson property recorded in Official Record Volume 1942, Page 427, and for the Mark R & Sharon S Burkholter recorded in Deed Book Volume 987, Page 17, also being in the roadbed of Morgan Road (County Road #123);
- TIE-2 THENCE South 81 degrees 23 minutes 35 seconds East 322.53 feet leaving said road, into said Section #1, and along the common line for said M & M Atkinson and Burkholter properties to an iron pin (set) at a common corner for said M & K Atkinson and M & M Atkinson properties, also being to the place of beginning for the property herein intended to be described, passing an iron pin (found) at 24.03 feet;
- #1- THENCE South 10 degrees 51 minutes 45 seconds West 192.32 feet through said M & K Atkinson property to an iron pin (set);
- #2- THENCE South 85 degrees 23 minutes 55 seconds West 41.04 feet continuing through said M & K Atkinson property to an iron pin (set) at a common corner for said M & K Atkinson and M & M Atkinson properties;
- #3- THENCE North 21 degrees 52 minutes 30 seconds East 207.08 feet along a common line for said M & K Atkinson and M & M Atkinson properties, to the place of beginning, containing 0.09 acres.
