DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, T-18, R-15, being a part of Fredrick Bates Vol. 1112 Pg. 173, being part of the Northwest Quarter of Section 18, and more particularly described as follows:

Beginning at an iron pin found at the Southeast Corner of the Northwest Quarter of Section 18; thence North 00 Degrees 01 Minutes 39 Seconds West 1151.97 feet to a point in the centerline of Co. Rd. 30; thence leaving said road North 83 Degrees 33 Minutes 51 Seconds West 378.73 feet to a point; thence North 78 Degrees 17 Minutes 51 Seconds West 123.46 feet to a point; thence North 07 Degrees 41 Minutes 05 Seconds East 12.54 feet to an iron pin found and the place of beginning; thence North 78 Degrees 17 Minutes 51 Seconds West 310.84 feet to an iron pin found; thence North 03 Degrees 53 Minutes 15 Seconds East 148.63 feet to an iron pin found; thence South 86 Degrees 06 Minutes 45 Seconds East 320.62 feet to an iron pin set; thence South 07 Degrees 41 Minutes 05 Seconds West 191.32 feet to the place of beginning, containing 1.23 acres, more or less, subject to all legal highways and easements.

Also the following 50 foot & 25 foot easement for ingress & egress.

Beginning at an iron pin found at the Southeast Corner of the Northwest Quarter of Section 18; thence North 00 Degrees 01 Minutes 39 Seconds West 1151.97 feet to a point in the centerline of Co. Rd. 30 and the place of beginning; thence leaving said road along the centerline of a 50.00 foot easement North 83 Degrees 33 Minutes 51 Seconds West 378.73 feet to a point; thence along the centerline of a 25.00 foot easement North 78 Degrees 17 Minutes 51 Seconds West 433.45 feet to a point.

Bearings are based on Mid Section Line of Section 18 as being North 00 Degrees 01 Minutes 39 Seconds West.




