SURVEY DESCRIPTION
FOR
Abundant Life Ministries

PART OF AUDITORS PARCEL
25-85-15-05-000 (0.22 Acres)

Situated in the Northwest quarter of section 15, T-18, R-15, Hopewell Township, Muskingum County, Ohio. Being part of the lands of Abundant Life Ministries as recorded in Deed Book 1658 Page 780 of the Muskingum County Deed Records and being described as follows:

Commencing at the Northwest corner of Section 15; thence, S.04°32'26"E. a distance of 212.25 feet along the West line of said section, also being the centerline of Hopewell Road, to a point on the Southwest corner of the lands, now or formerly, owned by W. & R. Ashworth (1763/909), BEING THE POINT OF BEGINNING;

Thence, **N.83°38'50"E.** a distance of **160.21** feet along the South line of Said Ashworth lands to a set rebar, passing a set rebar at 30.10 feet;

Thence, **S.04°28'05"E.** a distance of **56.13** feet through the lands of Abundant Life ministries, Inc. (1658/780) to a point in the middle of a small stream;

Thence, **S.74°37'30"W.** a distance of **70.75** feet through said Ministries lands, and along said stream to a point;

Thence, **N.86°33'09"W.** a distance of **91.46** feet through said Ministries lands, and along said stream to a point on the West line of the Northwest quarter of section 15, located near the center of Hopewell Road;

Thence, **N.04°32'26"W.** a distance of **51.65** feet along said section line and along said road to the point of beginning.

The above described parcel contains 0.22 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

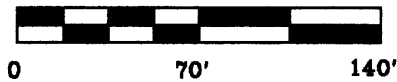

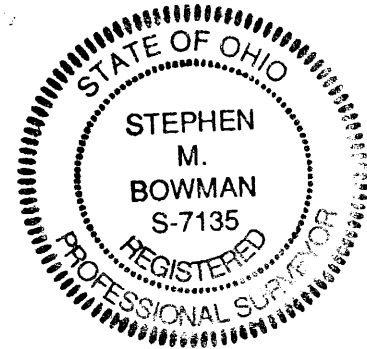
