**PART OF PARCEL  
29-10-01-04-000 (1.000 Acres)**

Situated in lot 6, Quarter Township 1, T-3-N, R-9-W, Jackson Township, Muskingum County, Ohio. Being part of the lands of F. Kilpatrick, Et Al, conveyed in Deed Book 915 page 5 of the Muskingum County Deed Records, and being described as follows:

Commencing at a found iron pin marking the Northeast corner of lot #6; thence, S.89°57'45"W. a distance of 743.81 feet along the North line of said lot 6 to a point in the center of County Road 94 (West Carlisle Road), **BEING THE POINT OF BEGINNING;**

thence, S.00°49'04"E. a distance of 150.01 feet along the center line of said road to a point;

thence, S.89°57'45"W. a distance of 290.43 feet through the lands of F. Kilpatrick, Et Al, (915/005) to a set rebar, passing a set rebar at 35.00 feet;

thence, N.00°49'04"W. a distance of 150.01 feet through said Kilpatrick lands to a point on the North line of lot 6, passing a set rebar at 76.53 feet;

thence, N.89°57'45"E. a distance of 290.43 feet along said lot line to the point of beginning, passing a set rebar at 255.43 feet.

The above described parcel contains 1.000 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

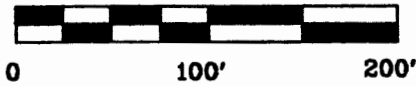

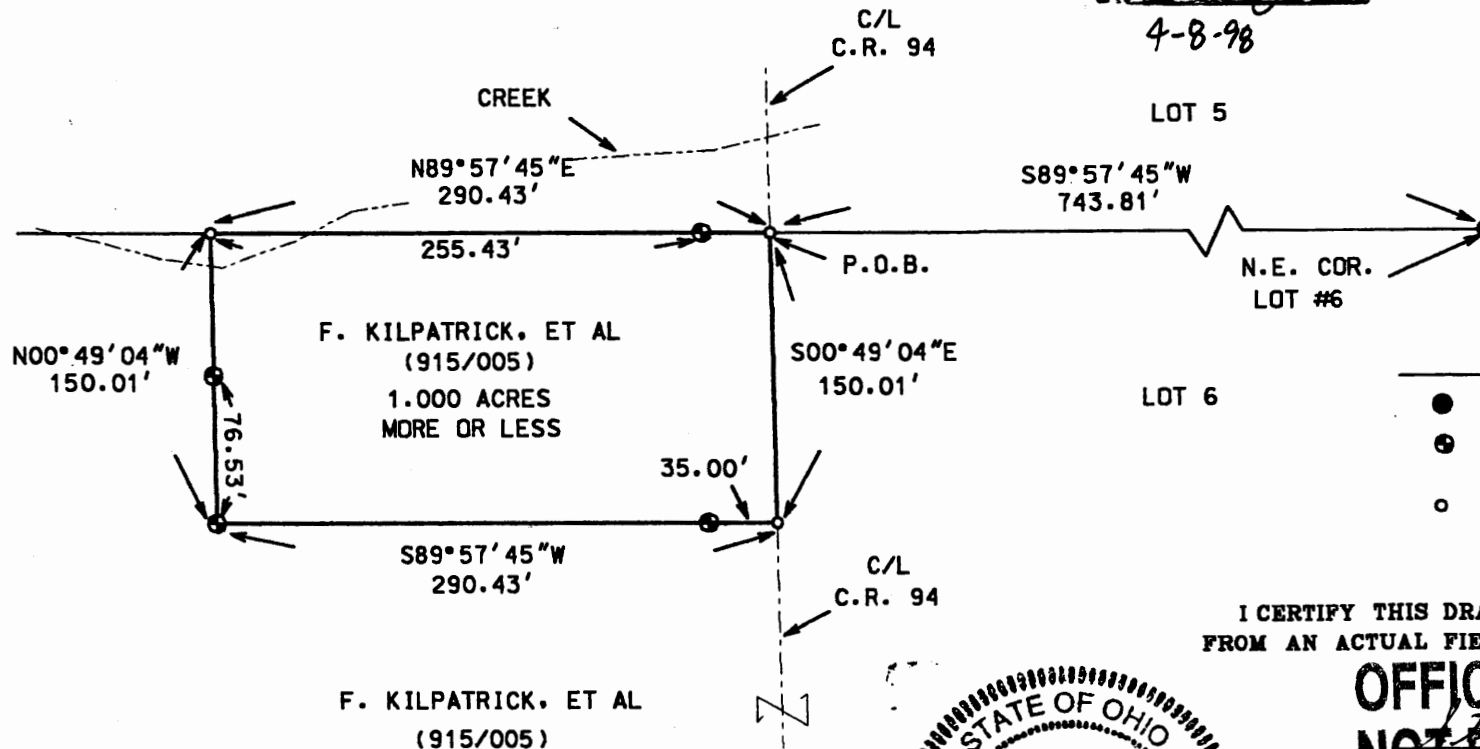
