Being a tract of land in Sections 3 & 8 and Lots 6 & 15, First Quarter, range 9W, Township 3N, Jackson Township, Muskingum County, State of Ohio and being further described as follows;

Note: North based on GPS observations, Ohio State Plane Coordinate system, North Zone, grid to ground. Research Data; deeds, surveys and plats of record.

Beginning at a triangular pointed stone (no X) recovered at the Southwest corner of Section 3 and being 3' N.N.W. of a 2.9' White Oak tree;

then with the West line of said Section 3 the following two (2) courses;

1. N 02° 49' 09" E, a distance of one-thousand two-hundred thirty-nine and eighty-seven hundredths (1239.87) feet to a 5/8" x 30" rebar with plastic cap set on the North side of Michael Road and on the South side of Wakatomica Creek;
2. Continuing N 02° 49' 09" E, a distance of eighty-five and no hundredths (85.00) feet to a point in the center of said Wakatomica Creek;

then with the said center of Wakatomica Creek the following 47 courses;

36. passing into Lot 6, S 42° 44' 14" E, a distance of one-hundred ten and nineteen hundredths (110.19) feet to a point;
37. S 06° 58' 58" E, a distance of sixty-six and eighty-six hundredths (66.86) feet to a point;
38. passing back into Section 8, S 34° 53' 37" W, a distance of seventyone and four hundredths (71.04) feet to a point;
39. S 53° 06' 58" W, a distance of one-hundred forty and twenty-three hundredths (140.23) feet to a point;
40. S 28° 29' 48" W, a distance of sixty-eight and fourteen hundredths (68.14) feet to a point;
41. S 19° 08' 03" E, a distance of ninety-four and twenty-three hundredths (94.23) feet to a point;
42. S 45° 07' 25" E, a distance of one-hundred twelve and forty hundredths (112.40) feet to a point;
43. passing back into Lot 6, S 64° 51' 17" E, a distance of one-hundred twenty-five and seventy hundredths (125.70) feet to a point;
44. S 48° 25' 55" E, a distance of eighty-nine and thirty-six hundredths (89.36) feet to a point;
45. S 22° 36' 48" E, a distance of one-hundred twenty-four and twenty-seven hundredths (124.27) feet to a point;
46. Passing into Lot 15, S 05° 43' 21" E, a distance of one-hundred eighteen and fifty-two hundredths (118.52) feet to a point;
47. S 03° 29' 32" W, a distance of twenty-five and eighteen hundredths (25.18) feet to a point at the Northeast corner of the lands of R.P. Kilpatrick (754/319);

then with the North line of the said lands of R.P. Kilpatrick (754/319) the following two courses;

1. N 87° 13' 29" W, a distance of four-hundred six and fifty-one hundredths (406.51) feet to a set 5/8" x 30" rebar with plastic cap;

2. Continuing N 87° 13' 29" W, a distance of two-thousand five hundred sixty-eight and eighty-three hundredths (2568.83) feet to a steel pin set on the East line of the lands D.E. & V.L. Michael (1893/348);

then with the East line of the said lands D.E. & V.L. Michael (1893/348), N 03° 10' 15" E, a distance of nine-hundred fourteen and fifty hundredths (914.50) feet to the point of beginning;

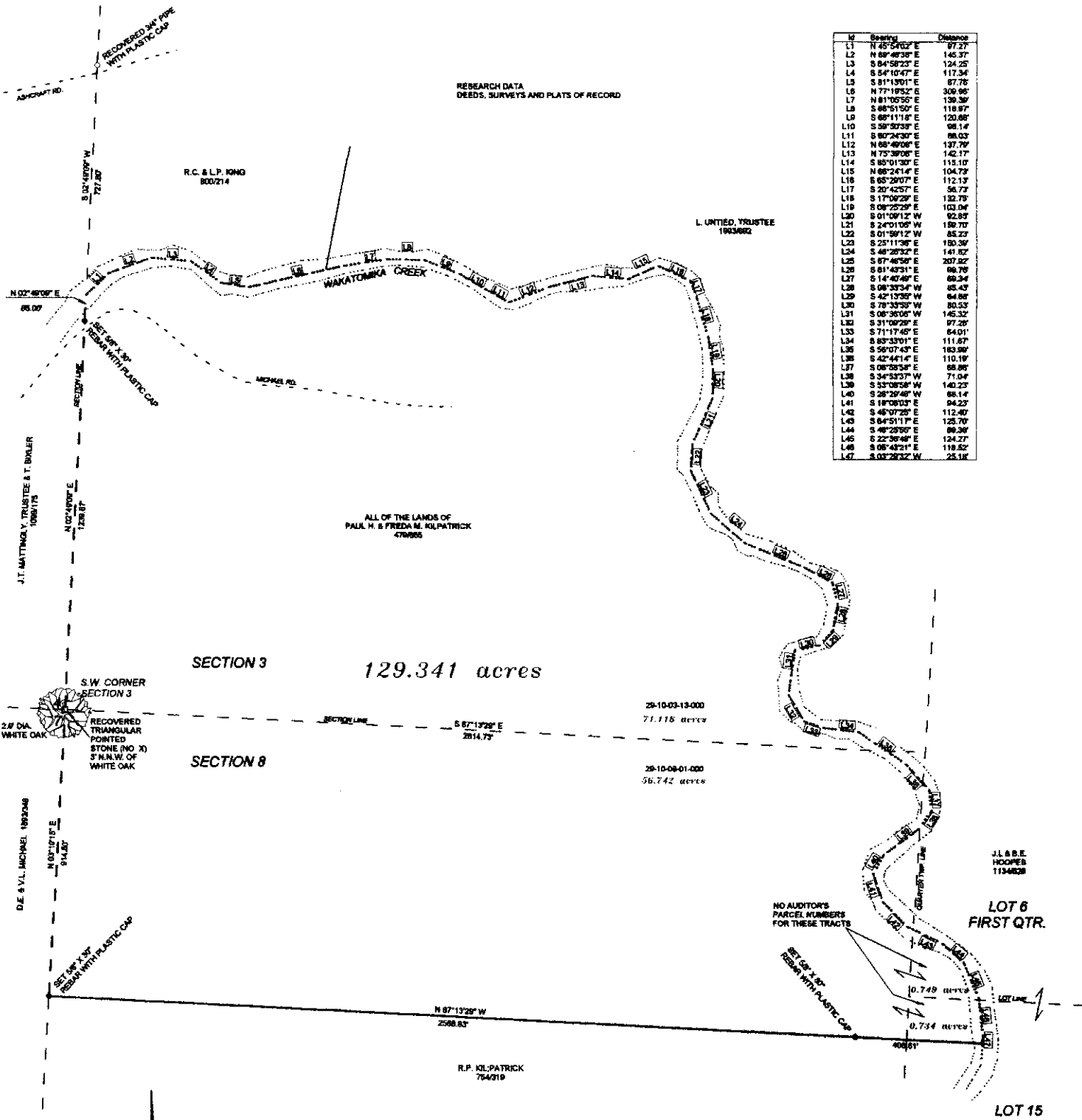
