Real Estate situated in the Township of Jackson, County of Muskingum and State of Ohio.

Being lands in the Southwest Quarter and in the Southeast Quarter of Section 4, T-3-N, R-9-W and a parcel in the Northwest Quarter of Section 7, T-3-N, R-9-W in the U. S. Military Lands district. Said lands and Parcel being more fully described as follows:

Beginning at the most Southeast corner of the Southwest Quarter of said Section 4; thence with the Southern Quarter section line, Westerly, N 88° 30' W 374.88 feet to a point in County Road #38; thence with said road four (4) courses, N 10° 15' E, 467.94 feet; N 28° 00' W, 399.96 ft.; N 16° 30' W, 299.97 ft. and N 23° 33' W, 475.23 ft.; thence leaving said County Road #38 N 26° 45' E, 799.92 ft. to the half Section line and being the North line of the Southwest Quarter; thence with said half Section line passing thru the center of aforesaid Section 4 and into the Southeast Quarter of Section 4 being S 88° 30' E, 622.38 ft. to a point; thence leaving said half Section line S 1° 30' <sup>W 106</sup> 1943.37 ft. to a point; thence S 88° 30' E, 454.74 ft.; thence S 2° 00' W, 306.57 ft. to a point on the South line of the aforesaid Southeast Quarter; thence with said line N 88° 30' W, 621.06 ft. to the place of beginning. Thus describing lands within Section 4 and being 27.75 Acres in the Southwest Quarter and 11.79 acres in the Southeast Quarter, being 39.54 acres in total in said Section 4.

The parcel of land situated in Section 7 being described as follows: Beginning at the Northeast corner of the Northwest Quarter of Section 7; thence S 1° 30' W, 66.0 ft. along the East Quarter line to a point; thence leaving said Quarter line N 88° 30' W, 165 ft.; thence N 1° 30' E, 66.0 ft. to the North Section line of said Section 7; thence with said line S 88° 30' E, 165.0 ft. to the place of beginning. Containing 0.25 acres in Section 7.

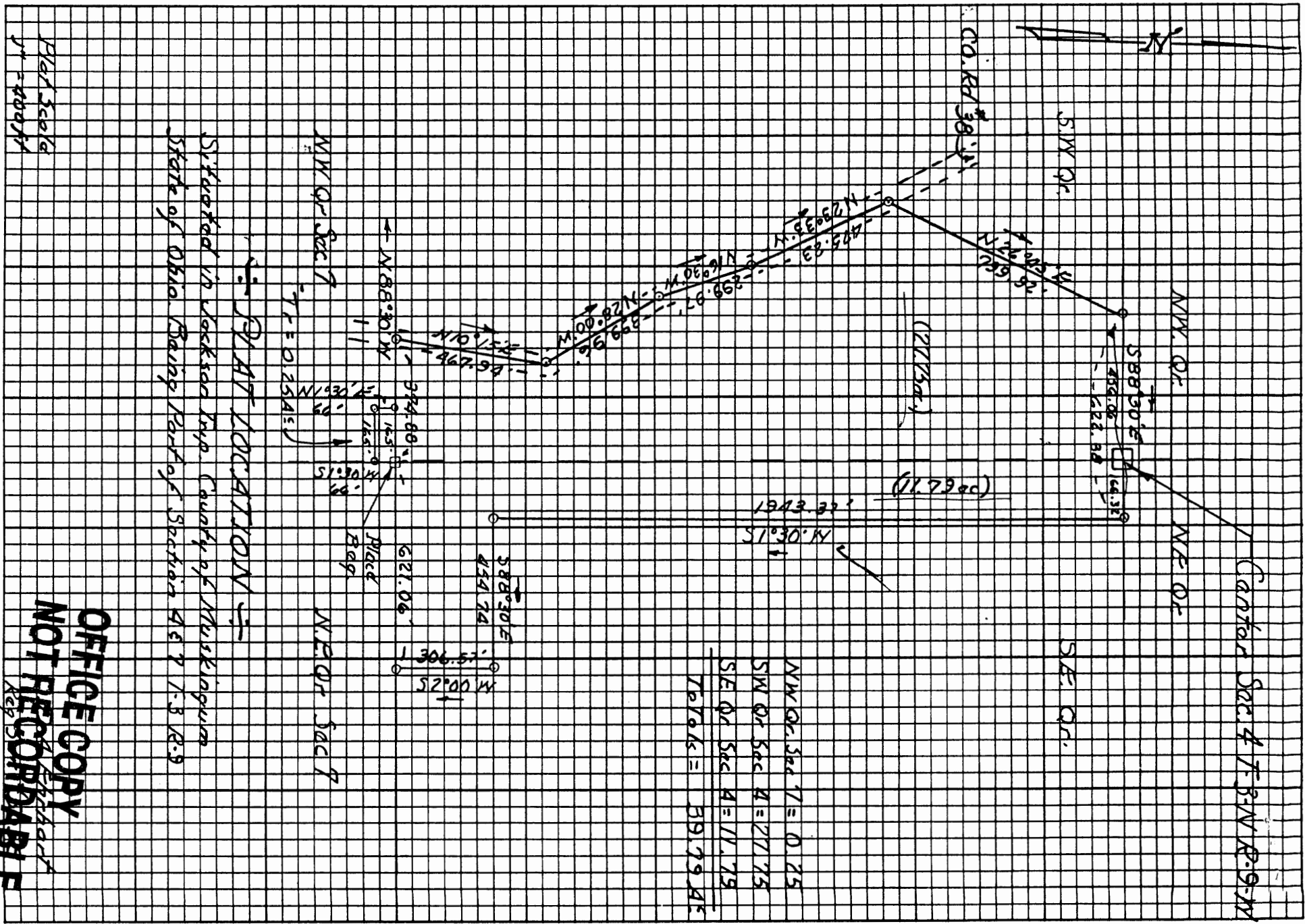
