

**Survey Split Two, +-18.50 Acres of The Clara Bell Fairall Revocable Trust, Clara Bell Fairall, Trustee,**

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the Southeast Quarter of Section 7, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by the Clara Bell Fairall Revocable Trust, Clara Bell Fairall, Trustee, as per Official Record 2779, Page 93, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at the northeast corner of the Southeast Quarter of Section 7, Township 3, Range 9, United States Military Lands;

Thence along the lines presently owned by Robert Paul Kilpatrick, (DR 754-319), the following two courses:

- 1.) South 87 degrees 27 minutes 41 seconds East, 45.89 feet to an iron pin found;
- 2.) South 02 degrees 30 minutes 48 seconds West, 201.00 feet to an iron pin set;

Thence through the lands presently owned by Clara Bell Fairall Revocable Trust, Clara Bell Fairall, Trustee, the following three courses:

- 1.) South 76 degrees 55 minutes 50 seconds West, 1335.32 feet to an iron pin set, passing the section line at 47.62 feet;
- 2.) South 41 degrees 56 minutes 12 seconds West, 272.54 feet to an iron pin set;
- 3.) South 56 degrees 32 minutes 04 seconds West, 315.83 feet to a point in the centerline of Hamby Hill Road, (Co. Rd. 38), passing an iron pin set at 298.03 feet;

Thence along the centerline of said road the following four courses:

- 1.) North 36 degrees 12 minutes 13 seconds West, 63.05 feet to a point;
- 2.) North 33 degrees 21 minutes 45 seconds West, 109.94 feet to a point;
- 3.) North 29 degrees 41 minutes 26 seconds West, 55.31 feet to a point;
- 4.) North 26 degrees 45 minutes 43 seconds West, 100.18 feet to a point on the southwest corner of lands presently owned by James A. and Audrey J. Redman, Trustees, (OR 1696-563);

Thence along the south line of said Redman lands, North 38 degrees 59 minutes 56 seconds East, 379.17 feet to an iron pipe found, on the southeast corner of lands presently owned by Dennis E. Cabot, (OR 1767-763, OR 2775-870, and OR 2938-905), and Lisa Cabot, and Matthew Cabot, (OR 2313-67), passing an iron pin found at 19.70 feet;

Thence along the south line of said Cabot's lands, North 39 degrees 18 minutes 14 seconds East, 477.82 feet to an iron pipe found on the Quarter Section Line and the south line of lands presently owned by AOK Investments, LLC, (OR 2817-639);

Thence along the Quarter Section Line and the south line of said Investments lands, South 87 degrees 18 minutes 32 seconds East, 1339.71 feet to the principal place of beginning, containing 18.50 acres, more or less, and being part of Auditor's Parcel Number 29-10-07-23-000.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid
