SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF JACKSON, AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 3, RANGE 9, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 776, PAGE 101; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 7, THENCE, ALONG THE QUARTER SECTION LINE, NORTH 00 DEGREES - 17 MINUTES - 12 SECONDS WEST, 954.96 FEET TO A POINT IN THE CENTERLINE OF COUNTY ROAD #38 AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 00 DEGREES - 17 MINUTES - 12 SECONDS WEST, 367.71 FEET TO AN IRON PIN FOUND, PASSING IRON PINS FOUND AT 52.13 FEET AND 177.29 FEET; THENCE, SOUTH 89 DEGREES - 54 MINUTES - 06 SECONDS EAST, ALONG THE SOUTH LINE OF THOSE LANDS RECORDED IN DEED VOLUME 1142, PAGE 902, 516.31 FEET TO AN IRON PIN SET; THENCE, SOUTH 07 DEGREES - 01 MINUTES - 51 SECONDS WEST, 442.86 FEET TO AN IRON PIN SET; THENCE, SOUTH 78 DEGREES - 50 MINUTES - 08 SECONDS EAST, 210.18 FEET TO A POINT IN THE CENTERLINE OF TOWNSHIP ROAD #93, PASSING AN IRON PIN SET AT 198.18 FEET; THENCE, ALONG THE CENTERLINE OF SAID TOWNSHIP ROAD, THE FOLLOWING SIX (6) COURSES AND DISTANCES:
