

DESCRIPTION OF PARCEL # 29 - 20 - 61 - 06 WHICH WAS CONVEYED TO BOWERSTON SHALE CO. INC. IN VOLUME 428, PAGE 360 OF MUSKINGUM RECORDS.

Situate in the State of Ohio, County of Muskingum, Township of Jackson, and being a part of the West half of lot # 14 in Quarter Township # 1, Township 3 North, Range 9 West, in the United States Military District and being a part of parcel # 29 - 20 - 61 - 06 as conveyed to Bowerston Shale Co. Inc. in Deed Volume 428, Page 360, of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning at an iron pin found at the Southeast corner of the West half of Lot # 7 in Quarter Township # 1, Township 3 North, Range 9 West, in the United States Military District, thence South 04 degrees 57 minutes 38 seconds East 28.24 feet to an iron pin set; thence along a gravel drive, South 84 degrees 15 minutes 56 seconds West 127.47 feet to a point at the intersection of said gravel drive and the centerline of West Carlisle rd. (Co. Rd. # 94), passing an iron pin at 109.76 feet; thence along the centerline of West Carlisle Rd., North 25 degrees 30 minutes 04 seconds West 9.59 feet to a point in said centerline; thence along said centerline, North 34 degrees 44 minutes 29 seconds West 33.28 feet to a point; thence along the south line of Donald E. And Barbara A. Parsons property (Vol. 1034 Pg. 551), North 88 degrees 06 minutes 35 seconds East 147.57 feet to an iron pin found at the Place of Beginning, passing an iron pin set at 18.81 feet.


