**THENCE CONTINUING WITH THE SAID COMMON LINE, NORTH 04 DEGREES 44 MINUTES 35 SECONDS EAST 116.61 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 94 (WEST CARLISLE ROAD);**






