KNOW ALL MEN BY THESE PRESENTS:

That Ivan N. Van Allen & Shirley C. Van Allen

hereinafter referred to as the "Grantor" in consideration of the sum of _____ Dollars (\$_____)

to it paid by the State of Ohio, for the County of Muskingum, the Grantee, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and assigns forever, the following described real estate:

Situated in the Township of Jackson, County of Muskingum, State of Ohio, and in Lot 22 & 23, Town 3-N, Range 9-W, and bounded and described as follows:

PARCEL NO. 36WV-1

Being a parcel of land lying on the left side of the centerline of a survey, made for the Department of Transportation, and recorded in Plat File _____, Slot _____, of the records of Muskingum County and being located within the following described points in the boundary thereof:

Commencing at the intersection of Lots 18, 19, 22, and 23 (iron pin found and used), said point being 1487.20 feet left of proposed S.R. 16 station 1039+10.54; thence S 00°45'31" E a distance of 1987.79 feet to a PK nail set, said point being on the centerline of Scout Rd. (C.R. 48) and being 0.31 feet right of station 20+80.97, and the TRUE PLACE OF BEGINNING of this description;

Thence with a curve to the right with an arc length of 529.79 feet, with a radius of 3819.72 feet, with a chord bearing of S 19°30'04" W, with a chord length of 529.36 feet to a point, said point being 0.31 feet right of station 15+51.35; thence S 23°28'28" W a distance of 171.98 feet to a point, said point being on the centerline of Scout Rd. (C.R. 48) and being station 13+79.36; thence N 86°48'03" W a distance of 71.29 feet to an iron pin set, said point being 66.87 feet left of station 13+54.66; thence N 16°18'36" E a distance of 684.95 feet to an iron pin set, said point being 120.00 feet left of station 20+50.00; thence N 30°47'40" W a distance of 82.89 feet to an iron pin set, said point being 160.00 feet right of Proposed S.R. 16 station 1028+00.00; thence with a curve to the left with an arc length of 230.60 feet, with a radius of 6410.45 feet, with a chord bearing of N 67°06'42" E, with a chord length of 230.62 feet to an iron pin set, said point being on the centerline of Scout Rd. (C.R. 48) and being station 22+52.75; thence S 15°31'40" W a distance of 171.78 feet to the True Place of Beginning.

Stationing for the above description is based on the centerline of Proposed State Route 16 and Scout Rd. (C.R. 48).

Bearings for the above description were based on the Ohio State Plane Coordinate System, South Zone NAD 83. Description of the above parcel is based on a survey made by Resource International, Inc. by Joseph S. Bolzenius, Registered Surveyor No. 7526, for the State of Ohio, Department of Transportation.

Iron Pin Set is 3/4" diameter, 30" long with plastic ID cap stamped "ODOT D-5".

The grantor reserves the right of ingress and egress to and from residual area.

Property owner claims title through instrument recorded in Volume 528 at Page 1076 in the Records of Muskingum County, Ohio.

The above parcel contains 2.093 acres, more or less of which the present road occupies 0.398 acres, more or less, leaving a net take of 1.695 acres.

The following is a breakdown according to Auditor's Parcel number:

1.191 acres more or less of which the present road occupies 0.153 acres, more or less, leaving a net take of 1.038 acres to be taken from Auditor's Parcel 29-29-50-01-13-000 which contains 76.070 acres.
