to it paid by the State of Ohio, for the County of Muskingum, the Grantee, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and assigns forever, the following described real estate:

Situated in the Township of Jackson, County of Muskingum, State of Ohio, and in Lot 22, Town 3-N, Range 9-W, and bounded and described as follows:

PARCEL NO. 37WV

Being a parcel of land lying on the left side of the centerline of a survey, made for the Department of Transportation, and recorded in Plat File _____, Slot _____, of the records of Muskingum County and being located within the following described points in the boundary thereof:

Commencing at the intersection of Lots 18, 19, 22, and 23 (iron pin found and used), said point being 1487.20 feet left of proposed S.R. 16 station 1039+10.54; thence S 11°43'22" E a distance of 1217.45 feet to a PK nail set, said point being on the centerline of Scout Rd. (C.R. 48) and being station 29+06.67, and the TRUE PLACE OF BEGINNING of this description;

Thence N 86°05'42" W along the Grantor's South line a distance of 142.93 feet to an iron pin set, said point being on the Grantor's South line and being 140.00 feet left of station 28+77.87; thence N 15°31'40" E a distance of 272.13 feet to an iron pin set, said point being 140.00 feet left of station 31+50.00; thence N 21°14'18" E a distance of 281.40 feet to an iron pin set, said point being 112.00 feet left of station 34+30.00; thence N 19°22'50" E a distance of 572.02 feet to an iron pin set, said point being 75.00 feet left of station 40+00.00; thence S 73°54'50" E a distance of 75.00 feet to an iron pin set, said point being on the centerline of Scout Rd. (C.R. 48) and being station 40+00.00; thence S 15°36'10" W along the centerline of Scout Rd. (C.R. 48) a distance of 1093.33 feet to the True Place of Beginning.

Stationing for the above description is based on the centerline of Proposed Scout Rd. (C.R. 48).

Bearings for the above description were based on the Ohio State Plane Coordinate System, South Zone NAD 83. Description of the above parcel is based on a survey made by Resource International, Inc. by Joseph S. Bolzenius, Registered Surveyor No. 7526, for the State of Ohio, Department of Transportation.

Iron Pin Set is 3/4" diameter, 30" long with plastic ID cap stamped "ODOT D-5".

The grantor reserves the right of ingress and egress to and from residual area.
