KNOW ALL MEN BY THESE PRESENTS:

That Rocky King

to it paid by the State of Ohio, for the County of Muskingum, the Grantee, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and assigns forever, the following described real estate:

Situated in the Township of Jackson, County of Muskingum, State of Ohio, and in Section 12, Town 3-N, Range 9-W, and bounded and described as follows:

**PARCEL NO. 45WV**

Being a parcel of land lying on the right side of the centerline of a survey, made for the Department of Transportation, and recorded in Plat File \_\_\_\_\_, Slot \_\_\_\_\_, of the records of Muskingum County and being located within the following described points in the boundary thereof:

Commencing at the intersection of Lots 18, 19, 22, and 23 (iron pin found and used), said point being 1487.20 feet left of proposed S.R. 16 station 1039+10.54; thence S 08°50'14" W a distance of 3534.51 feet to a PK nail set, said point being on the Grantor's South line and being at a 39.31 feet right of station 4+73.51, and the TRUE PLACE OF BEGINNING of this description;

Thence N 87°21'21" W along the Grantor's South line a distance of 41.34 feet to an iron pin set, said point being on the centerline of Scout Rd. (C.R. 48) and being 1.22 feet right of station 4+57.59; thence N 22°59'48" E along the centerline of Scout Rd. (C.R. 48) a distance of 267.86 feet to an iron pin set, said point being on the centerline of Scout Rd. (C.R. 48) and the Grantor's North line and being 0.51 feet left of station 7+25.43; thence S 89°09'54" E along the Grantor's North line a distance of 56.19 feet to an iron pin set, said point being 51.47 feet right of station 7+46.82; thence S 25°45'57" W a distance of 275.00 feet to the True Place of Beginning.

Stationing for the above description is based on the centerline of Proposed Scout Rd. (C.R. 48).

Bearings for the above description were based on the Ohio State Plane Coordinate System, South Zone NAD 83. Description of the above parcel is based on a survey made by Resource International, Inc. by Joseph S. Bolzenius, Registered Surveyor No. 7526, for the State of Ohio, Department of Transportation.

Iron Pin Set is 3/4" diameter, 30" long with plastic ID cap stamped "ODOT D-5".

The grantor reserves the right of ingress and egress to and from residual area.

Property owner claims title through instrument recorded in Volume 1089 at Page 139 in the Records of Muskingum County, Ohio.

The above parcel contains 0.280 acres, more or less of which the present road occupies 0.124 acres, more or less, leaving a net take of 0.156 acres to be taken from Auditor's Parcel 29-29-50-12-02-000 which contains 2.140 acres.
