FIRST PARCEL: Being part of the Northeast Quarter of Section 19, Township 3, Range 9, commencing at a stone at the Northwest corner of Lot 1 of Bagents Addition to Frazesburg; thence West for 199.67 feet to an iron pin and the point of beginning; thence West along the half section line for 751.42 feet to an iron pin; thence N 65° 06'11" E for 828.41 feet to an iron pipe in concrete (distance 927 feet on previous deed corrected) at the Northwest corner of Lot 21 of Goff and Blizzards Addition to said Village, thence South 348.75 feet to the point of beginning containing 3.01 acres.

Also Lots Number Twenty-one (21) and Twenty-two (22) in Goff and Blizzard's Addition to the Village of Frazesburg, according to the recorded plat of said Addition in the Recorder's Office of Muskingum County, Ohio.


