Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the South Half of Section 25, and the part of the Southwest Quarter of Section 24, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by Ohio River Valley Pipeline, LLC as per Official Record 2523, Page 701, and Official Record 2523, Page 698, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Southwest Corner of Section 25, Township 3, Range 9, United States Military Lands;

Thence along the Jackson\Licking Township line, South 87 degrees 54 minutes 28 seconds East, 1251.21 feet to an iron pipe found, on the south line of a railroad presently owned by the State of Ohio, Ohio Rail Development Commission, (OR 2397-658);

Thence continuing along said Township Line the following two courses:

- 1.) South 87 degrees 47 minutes 36 seconds East 2093.71 feet to an iron pipe found;
- 2.) South 88 degrees 23 minutes 12 seconds East, 1439.81 feet to an iron pipe found on the southwest corner of lands presently owned by Paul and Sue Green, (OR 1955-850);

Thence along the west line of said Green lands, and the lands presently owned by the National Oil and Gas Cooperative LLC, (OR 2010-13, DR 1113-11), North 14 degrees 58 minutes 29 seconds West, 855.11 feet to a point in the centerline of an existing gravel drive, and the principal place of beginning, passing an iron pin found at 445.29 feet, and an iron pin set at 844.30 feet;

Thence along the centerline of said gravel drive the following thirteen courses:

- 1.) North 82 degrees 37 minutes 00 seconds West, 29.59 feet to a point;
- 2.) Along a non tangent curve to the right, with a delta angle of 80 degrees 30 minutes 36 seconds, a radius of 109.68 feet, an arc length of 154.13 feet, and a chord which bears North 39 degrees 30 minutes 33 seconds West, 141.76 feet to a point;
- 3.) North 02 degrees 36 minutes 57 seconds West, 199.42 feet to a point;
- 4.) Along a non-tangent curve to the right with a delta angle of 77 degrees 44 minutes 44 seconds, a radius of 114.23 feet, an arc length of 155.00 feet, and a chord which bears North 35 degrees 21 minutes 02 seconds East, 143.38 feet to a point;
- 5.) North 69 degrees 56 minutes 50 seconds East, 134.72 feet to a point;
- 6.) North 68 degrees 47 minutes 04 seconds East, 320.17 feet to a point;
- 7.) North 69 degrees 32 minutes 06 seconds East, 166.81 feet to a point;
- 8.) Along a non-tangent curve to the left, with a delta angle of 49 degrees 25 minutes 41 seconds, a radius of 97.41 feet, an arc length of 84.03 feet, and a chord which bears North 43 degrees 17 minutes 54 seconds East, 81.45 feet to a point;
- 9.) North 00 degrees 05 minutes 29 seconds West, 96.98 feet to a point;
- 10.) Along a non-tangent curve to the right, with a delta angle of 40 degrees 32 minutes 09 seconds, a radius of 135.30 feet, an arc length of 95.72 feet, and a chord which bears North 30 degrees 29 minutes 47 seconds East, 93.74 feet to a point;
- 11.) North 56 degrees 38 minutes 40 seconds East, 117.70 feet to a point;
- 12.) North 59 degrees 42 minutes 34 seconds East, 129.63 feet to a point;
- 13.) North 62 degrees 57 minutes 27 seconds East, 143.71 feet to a point in the centerline of
