COMMENCING AT AN EXISTING AXLE AT THE SOUTHWEST CORNER OF LOT  
NUMBER 22 OF SAID ADDITION; THENCE NORTH 24 DEGREES 35 MINUTES 00  
SECONDS WEST 165.00 FEET ALONG THE EASTERLY LINE OF MAIN STREET TO A  
POINT, AT THE NORTHWEST CORNER OF A TRACT CONVEYED TO B. AND E.  
KURTZ AS RECORDED IN DEED VOLUME 716 PAGE 59 OF SAID COUNTY RECORDS,  
SAID POINT BEING NORTH 65 DEGREES 33 MINUTES 04 SECONDS EAST 0.26  
FEET FROM AN EXISTING CONCRETE MONUMENT, SAID POINT ALSO BEING THE  
PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED,  
PASSING AN EXISTING AXLE AT 47.50 FEET; THENCE CONTINUING ALONG THE  
EASTERLY LINE OF SAID MAIN STREET NORTH 24 DEGREES 35 MINUTES 00  
SECONDS WEST 224.65 FEET TO A RAIL ROAD SPIKE SET ON THE WESTERLY  
LINE OF CANAL STREET; THENCE LEAVING SAID MAIN STREET AND ALONG THE  
WESTERLY LINE OF CANAL STREET SOUTH 53 DEGREES 36 MINUTES 14 SECONDS  
EAST 257.24 FEET TO A POINT AT THE NORTHEAST CORNER OF SAID KURTZ  
TRACT SAID POINT BEING NORTH 53 DEGREES 36 MINUTES 14 SECONDS WEST  
43.27 FEET AND 83.36 FEET FROM EXISTING IRON PINS (1/2 INCH REBAR);  
THENCE LEAVING THE WESTERLY LINE OF SAID CANAL STREET AND ALONG THE  
NORTH LINE OF SAID KURTZ TRACT SOUTH 65 DEGREES 33 MINUTES 04  
SECONDS WEST 124.79 FEET TO THE PLACE OF BEGINNING, PASSING AN  
EXISTING AXLE AT 0.62 FEET.

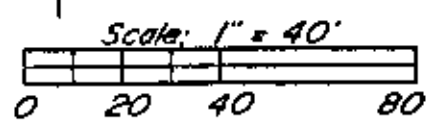
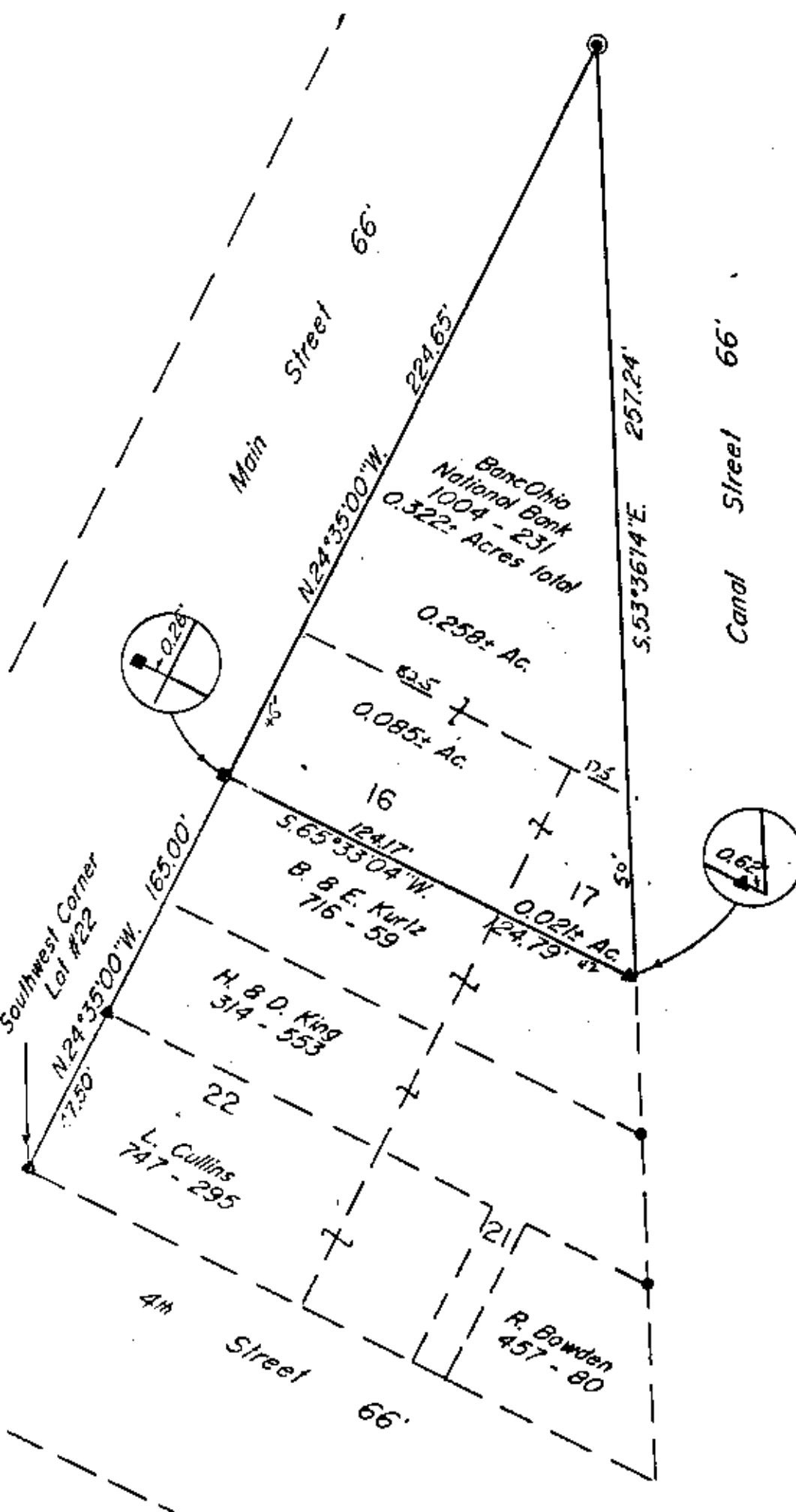
