AUDITORS PARCELS

33-10-16-09-000 (0.302 Acres), PART
33-10-16-02-000 (0.150 Acres), ALL
33-10-16-03-000 (0.286 Acres), ALL

Situated in the Village of Dresden, Muskingum County, Ohio. Being part of the lands conveyed to Helen Short and Hannah Martin in deed book 1024 page 495 and 499 of the Muskingum County Deed Records, and being described as follows:

Commencing at the Southeast corner of the intersection of Sillman Street and Fourth Street; thence, S.23°00'01"E. a distance of 80.20 feet along the extended east line of Sillman Street to a set iron pin, **BEING THE POINT OF BEGINNING;**

thence, N.72°33'30"E. a distance of 132.62 feet to a set iron pin on the West line of an alley;

thence, S.23°00'01"E. a distance of 237.01 feet along the west line of said alley to a found iron pin on the North line of 5th Street;

thence, S.66°59'57"W. a distance of 132.00 feet along 5th Street to a set iron pin on the extended East line of Sillman Street;

thence, N.23°00'01"W. a distance of 249.86 feet along said street to the point of beginning.

The above described parcel contains 0.738 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

Also attached to the above described parcel is a 10 wide easement for ingress and egress along the entire North line of said parcel.

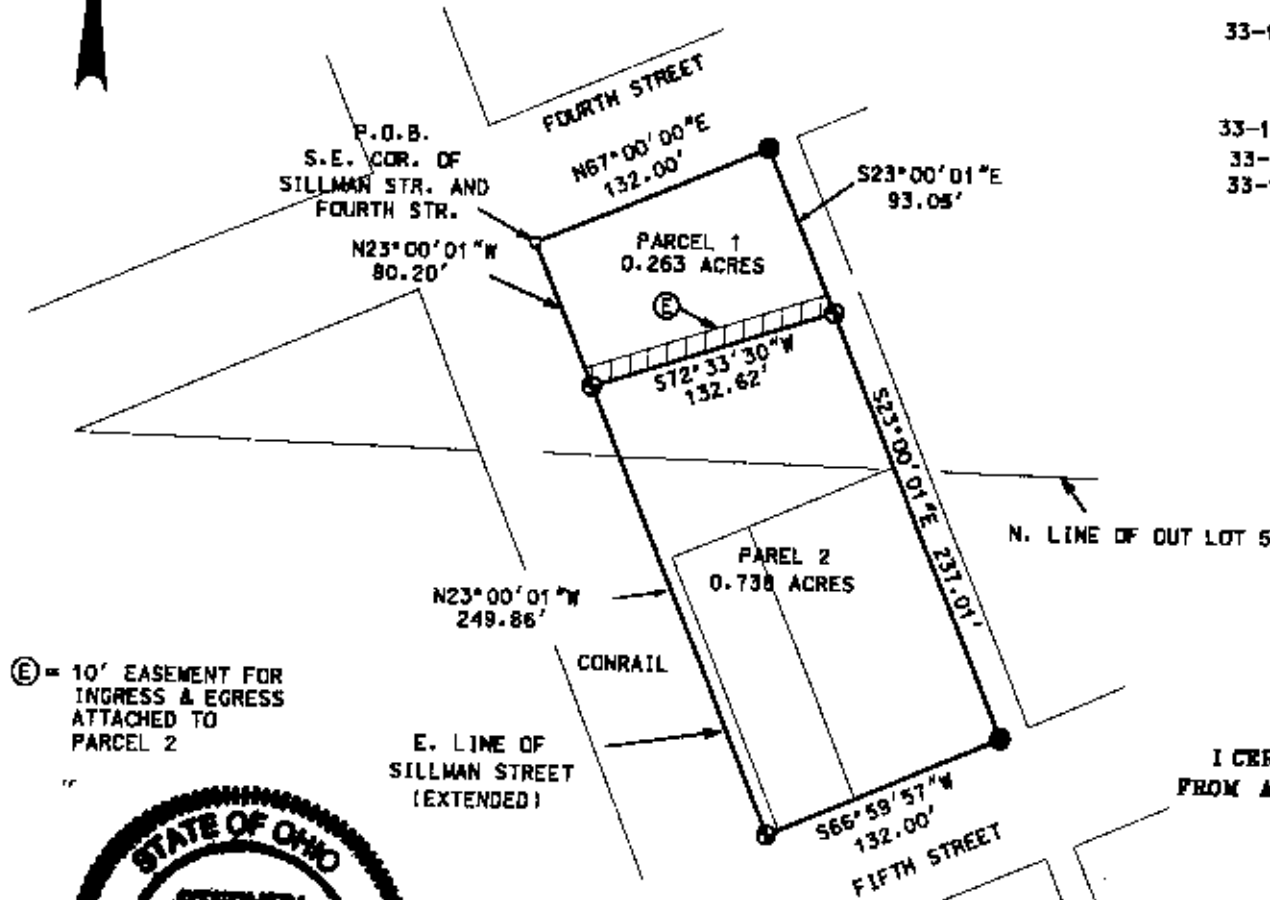
