

Alley Vacation

Situated in the State of Ohio, County of Muskingum, Town of Dresden, and being part of Longaberger's Foral Hills Subdivision No. 2, as per Plat Book 11, Page 23, of the Muskingum County records, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an iron pipe found at the Northwest Corner of Lot 21 of said subdivision;

Thence along the west line of Lots, 19, 20, and 21, and the east line of the alley to be vacated, South 21 degrees 10 minutes 56 seconds East, 270.39 feet to an iron pin found on the Southwest corner of Lot 19, passing iron pins found at 89.95 feet, 135.34 feet, and 180.39 feet;

Thence with an extension of the south line of Lot 19, South 68 degrees 49 minutes 04 seconds West, 19.50 feet to a point on the west line of said alley, and the east line of lands presently owned by G. A. Morrison, (OR 2028-673);

Thence along the west line of said alley and the east line of said Morrison lands, North 21 degrees 10 minutes 56 seconds West, 270.39 feet to a point on the south line of Fifth Street;

Thence along the south line of said street, North 68 degrees 49 minutes 04 seconds East, 19.50 feet to the principal place of beginning, containing 0.12 acres more or less.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

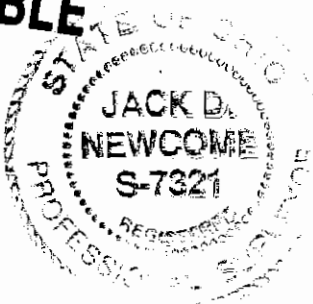

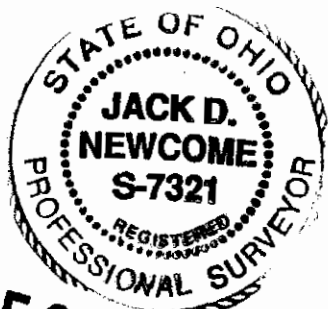
