Parcel #1 being part of a street plated in said Smith's Addition as 2 Rods wide and running between West Street and East Street, said section of street lying between lots #23 & #32 and also lying between lots #22 & #33 of said Smith's Addition.

Commencing at an iron pipe (found) at the Southwest corner of lot #20 of said Smith's Addition; thence along the South line of said lot #20 and along the North line of said vacated street N  $65^{\circ}$  00' 00" E ( 66.00 ) feet to an iron pin (set) at the Southwest corner of said lot #21 this being the place of beginning for the section of vacated street herein intened to be described; thence along the South lines of lots #21 & #22 also continuing along the North line of said street N 65° 00' 00" E ( 132.00 ) feet to an iron pin (set) at the Southeast corner of said lot #22; thence along the West line of said East Street S 25° 00' 00"  $\pi\epsilon$ ( 33.00 ) feet to an iron pin (set) at the Northeast corner of said lot #33 also being on the South line of said vacated street; thence along the North lines of said lots #33 & #32 also along the South line of said vacated street S 65 $^{

Parcel #2 being part of alley plated in said Smith's Addition as 17 feet wide and rnnning between West Street and East Street, said section of alley adjoining lots #32 & #33 in said Smith's Addition.

Beginning at an iron pin (set) at the Southeast corner of said lot #33 and on the West line of East Street; thence along the West line of East Street S  $25^{\circ}$  00' 00" E ( 8.50 ) feet to an iron pin (set) in the center of said 17 foot alley; thence along the center of said alley S  $65^{\circ}$  00' 00" W ( 132.00 ) feet to an iron pin (set); thence leaving the center of said alley N  $25^{\circ}$  00' 00" W ( 8.50 ) feet to an iron pin (set) at Southwest corner of said lot #32; thence along the Northline of said alley also along the Sonth lines of said lots #32 & #33 N  $65^{\circ}$  00' 00" E ( 132.00 ) feet to the place of beginning containing ( 0.026 ) acres.


