DESCRIPTION FOR THE LONGABERGER COMPANY 33-50-11-06 0.442 ACRE PARCEL

Situated in the State of Ohio, County of Muskingum, Town of Dresden, located in Section 4, Township—3—North, Range—8—West, United States Military Lands, being 0.442 acres out of Out Lot 44 in the Town of Dresden as recorded in Plat Book A—O, Page 128, all references being to those of record in the Recorder's Office, Muskingum County, Ohio, said 0.442 acre parcel being more particularly bounded and described as follows:

Beginning at an iron [|]pin set marking the intersection of the southerly right—of—way line of Muskingum Street with the easterly right—of—way line of Main Street, said pin also marking the northwesterly corner of Out Lot 44;

thence North 67'00'00" East, along the southerly right—of—way line of Muskingum Street, a distance of 147.70 feet to an iron pin set;

thence South 06'37'11" West, across said Out Lot 44, a distance of 299.66 feet to an iron pin set in the epsterly right—of—way line of Main Street;

thence North 22°54'43" West, along the easterly right—of—way line of Main Street, a distance of 260.50 feet to the Point of Beginning and containing 0.442 acres, more or less, according to a survey made by Jobes Henderson, Inc., in May, 1996.

The bearings in the above description are based or the northerly line of Out Lot 44, as being North 67'00'00" East, as recorded in Deed Book 860, Page 91.

All iron pins set are 5/8" in diameter by 30" in length with red surveyors identification caps marked J & H.

DESCRIPTION FOR LONGABERGER COMPANY A 0.168 ACRE PARCEL

Situated in the State of Ohio, County of Muskingum, Town of Dresden, located in Section 4, Township—3—North, Range—8—West, United States Military Lands, being a strip of land 22.5 feet in width across part of Out Lot 44 as delineated upon the Town Plat of Dresden, as recorded in Plat Book A—O, Page 128, all references being to those of record in the Recorder's Office, Muskingum County, Ohio, said strip being more particularly bounded and described as follows:

Beginning for reference at an iron pin set marking the intersection of the southerly right—of—way line of Muskingum Street with the easterly right—of—way line of Main Street, said pin also marking the northwesterly corner of Out Lot 44;

thence North 67'00'00" East, along the southerly right—of—way line of Muskingum Street, a distance of 147.70 feet to an iron pin set and being the True Point of Beginning for the following described strip of land;

thence North 67'00'00" East, continuing along the southerly right—of—way line of Muskingum Street, a distance of 25.88 feet to an iron pin set;

thence South 06'37'1'"West, across Out Lot 44, a distance of 352.17 feet to an iron pin set in the easterly right-of-way line of Main Street;

thence North 22°54'43" West, along the easterly right—of—way line of Main Street, a distance of 45.65 feet to an iron pin set;

thence North 06°37'11" East, across Out Lot 44, a distance of 299.66 feet to the True Point of Beginning and containing 0.168 acres, more or less.

Situated in the State of Ohio, County of Muskingum, Town of Dresden, located in Section 4, Township-3-North, Range-8-West, United States Military Lands, being 0.765 acres out of Out Lot 44 in the Town of Dresden as recorded in Plat Book A-O, Page 128, all references being to those of record in the Recorder's Office, Muskingum County, Ohio, said 0.765 acre parcel being more particularly bounded and described as follows.

Beginning for reference at an iron pin set marking the intersection of the southerly right—of—way line of Muskingum Street with the easterly right—of—way line of Main Street, said pin also marking the northwesterly corner of Out Lot 44;

thence North 67'00'00" East, along the southerly right—of—way of Muskingum Street, a distance of 181.25 feet to an existing 3/4" open pipe marking the True Point of Beginning for the following described 0.765 acre parcel;

thence South 22[•]59'01" East, leaving the southerly right—of—way line of Muskingum Street and along the westerly line of that 1.22 acre tract as conveyed to Kim A. Mitchell by deed of record in Deed Book 860, Page 91, a distance of 330.00 feet to an existing 3/4" open pipe in the northerly line of Out Lot 47;

thence South 67'00'00" West, along the northerly line of Out Lot 47 and the southerly line of Out Lot 44, a distance of 181.67 feet to an iron pin set in the easterly rightof-way line of Main Street;

thence North 22°54'43" West, along the easterly right—of—way line of Main Street, a distance of 23.85 feet to an iron pin set;

thence North 06°37'11" East, leaving the easterly right—of—way line of Main Street and across said Out Lot 44, a distance of 352.17 feet to an iron pin set in the southerly right-of-way line of Muskingum Street:

thence North 67'00'00" East, along the southerly right—of—way line of Muskingum Street, a distance of 7.67 feet to the True Point of Beginning and containing 0.765 acres, more or less, according to a survey made by Jobes Henderson & Associates, Inc., in May,

The bearings in the above description are based or the northerly line of Out Lot 44, as being North 67'00'00" East, as recorded in Deed Book 860, Page 91. All iron pins set are 5/8" in diameter by 30" in length with red surveyors identification caps marked J & H.
