Being a part of outlot number 51 and all of outlot number 52 of the town plat of Dresden as shown on the plat recorded in plat book A-0, Page 128-130 of Muskingum County Plat Records, a part of Lots 23 and 24 of Tomlinson's Addition to the Village of Dresden as shown on the plat recorded in Deed Book "W", pages 46 and 47 of the Muskingum County Deed Records, and a part of the Third Quarter of Township Three, Range Seven, of the United States Military Lands, Jefferson Township, Muskingum County, Ohio and being further described as follows:

Beginning at an existing iron pin (3/4 inch rebar) at the northeast corner of Lot Number 23 of said Tomlinson's Subdivision; thence North 00 degrees 40 minutes 09 seconds west 95.34 feet along the east line of lot number 22 of said subdivision to a point in the center of Muskingum Street; thence South 85 degrees 36 minutes 33 seconds east 373.13 feet to the edge of the water of Muskingum River, passing an existing iron pin (3/4 inch rebar) at 172.88 feet; thence with said river and following the meanderings thereof a straight line of which runs south 03 degrees 42 minutes 47 seconds west 1467.92 feet to the north right-of-way line of the Dresden side cut of the Ohio canal; thence leaving the said river and along the said right-of-way North 54 degrees 12 minutes 50 seconds West 457.39 feet to an existing iron pin (5/8 inch rebar) at the southwest corner of outlot number 52 and passing an existing iron pin (5/8 inch rebar) at 15.00 feet; thence North 24 degrees 59 minutes 47 seconds west 174.51 feet along the west line of said outlot to an existing iron pin (5/8 inch rebar) at the northwest corner of said outlot; thence North 04 degrees 11 minutes 21 seconds West 158.20 feet to a p/k nail set in a tree stump, said nail being South 71 degrees 15 minutes 31 seconds east 10.00 feet from an iron pin set; thence North 03 degrees 00 minutes 25 seconds west 714.09 feet to an iron pin set on the North line of lot number 23 of the above mentioned Tomlinson's Subdivision; thence North 65 degrees 00 minutes 59 seconds east 240.44 feet along the said north line to the place of beginning.

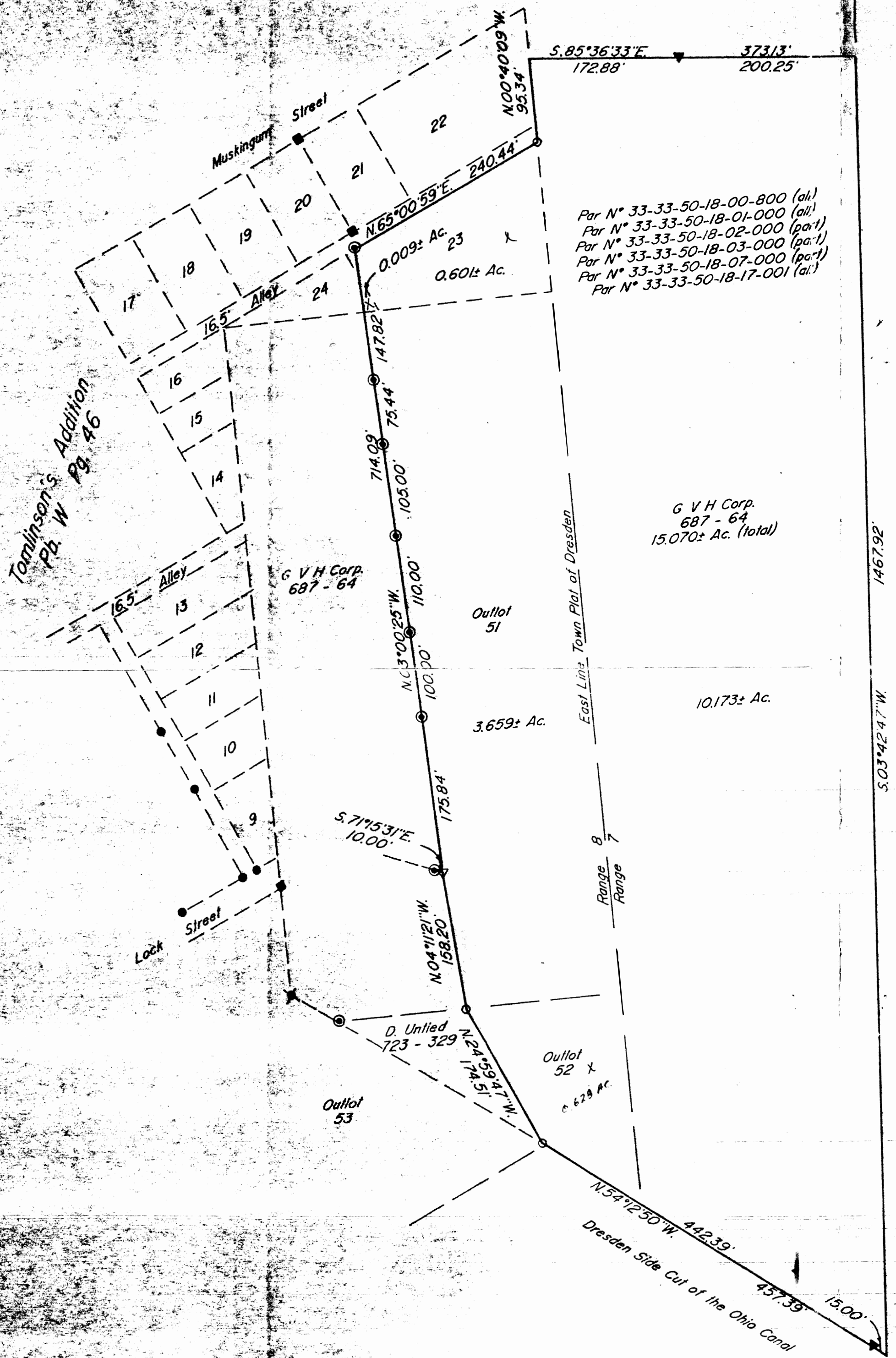
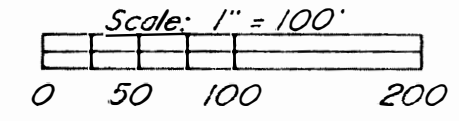

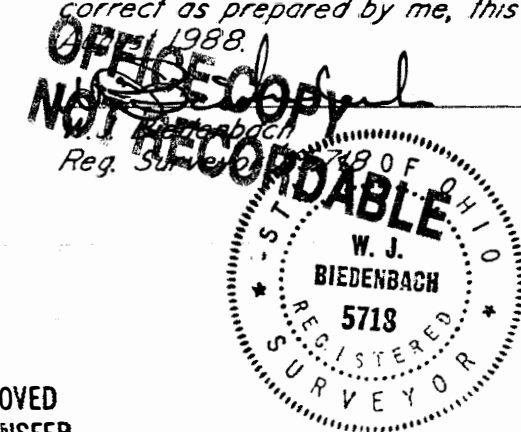
