2, township 2, range 9 bounded and described as follows.

Commencing at the southeast corner of McKee's  
Subdivision and recorded in plat book 15, page 7 of the  
plat records of said county; thence south a distance of  
277.93 feet to a point in the center line of old state route  
146; thence south 76 degrees 14 minutes 39 seconds east  
along said centerline a distance of 14.40 feet to the true  
place of beginning for the parcel herein intended to be  
described; thence continuing south 76 degrees 14 minutes 39  
seconds east along said centerline a distance of 60.32 feet  
to a point; thence south 17 degrees 50 minutes 00 seconds  
west along the westerly line of lands now or formerly owned  
by J. Cramer a distance of 227.60 feet to an existing iron  
pin and passing through an existing iron pin at 29.80 feet;  
thence north 71 degrees 55 minutes 20 seconds west along the  
northerly line of lands now or formerly owned by J.S.W.  
and recorded in deed book 492, page 587 of the deed records  
of said county a distance of 129.13 feet to an existing  
iron pin; thence north 34 degrees 43 minutes 29 seconds east  
along the easterly line of lands now or formerly owned by  
McKee a distance of 232.80 feet to the true place of beginning  
and passing through an iron pin at 200.31, containing  
Forty Nine (0.49) hundredths of an acre more or less

Subject to the easement of all legal highways.

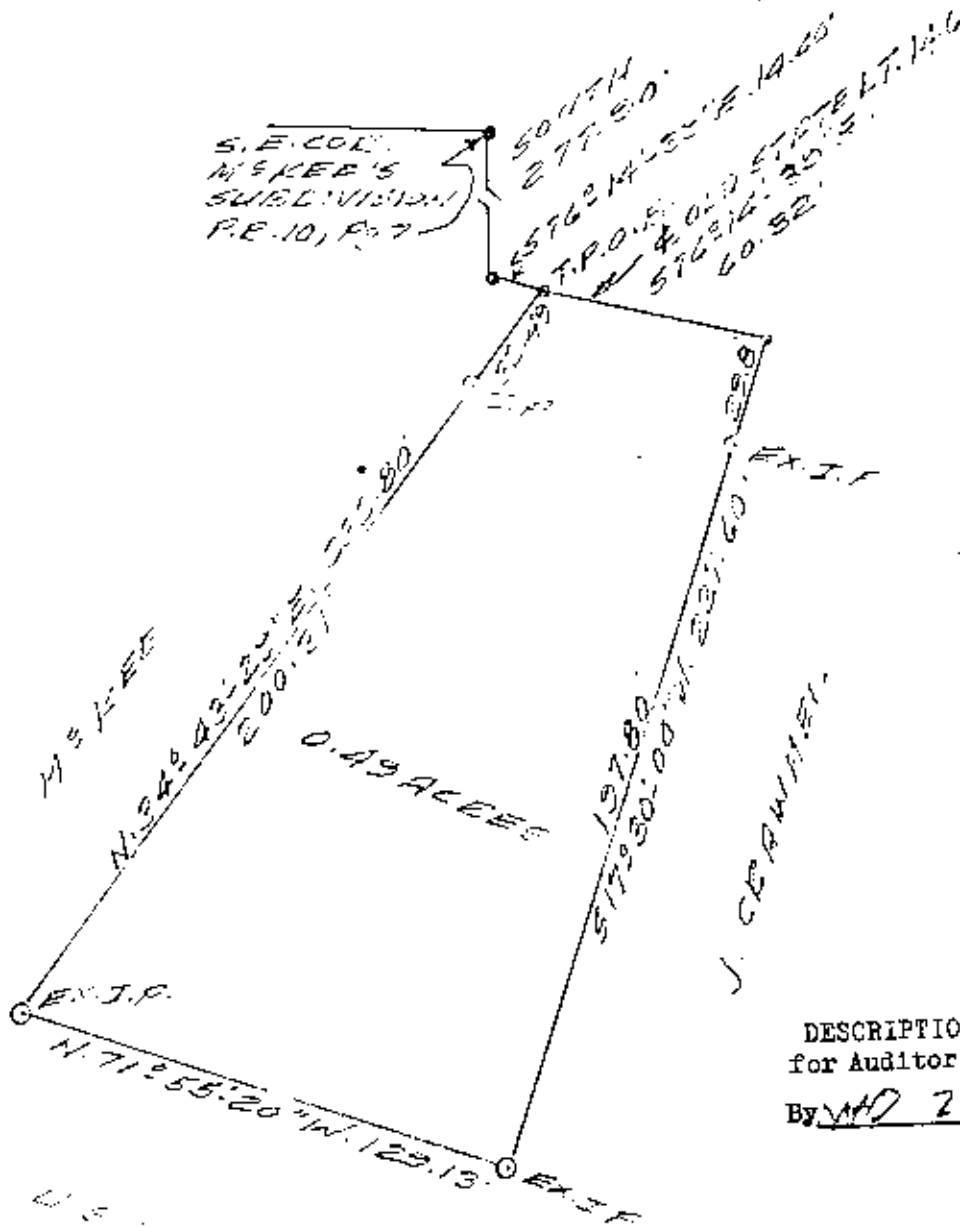
