Being 1.000 acres, more or less, in the Second Quarter, Township 2 North, Range 9 West, United States Military Lands, in the Township of Licking, in the County of Muskingum, in the State of Ohio, conveyed to Larry L. Law, DR 1122-413 (part), Parcel No. 35-02-51-34-001 (part), 0.575 acres and DR \_\_\_\_ - \_\_\_\_ (all), Parcel No. 35-06-02-01-\_\_\_\_ (all), 0.425 acres, and more particularly described as follows:

Commencing at a concrete monument found on the South right-of-way of State Route 146, said monument being 50.00' right of centerline Station 87+24.40 based on a 1966 survey by the Ohio Department of Highways, said concrete monument being the TRUE POINT OF BEGINNING;

thence, with the South right-of-way of State Route 146 (1966 survey), S. 49° 18' 53" E. a distance of 253.10' to a concrete monument found;

thence, with the North right-of-way of Old Newark Road, County Road 704, S. 87° 16' 22" W. a distance of 212.72' to a 5/8" steel pin set;

thence, through Old Newark Road, County Road 704, S. 06° 41' 40" W. a distance of 30.40' to a point;

thence, with the centerline of Old Newark Road, County Road 704, S. 87° 26' 00" W. a distance of 114.76' to a point;

thence, through the property of Larry L. Law, DR 1122-413, the following two courses;

1. thence, N. 06° 41' 40" E. a distance of 20.00' to a 5/8" steel pin set;
2. thence, N. 06° 41' 40" E. a distance of 215.79' to a 5/8" steel pin set on the South right-of-way of State Route 146 (1966 survey);

thence, with the South right-of-way of State Route 146 (1966 survey), S. 77° 57' 28" E. a distance of 113.76' to the TRUE POINT OF BEGINNING, containing 1.000 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.

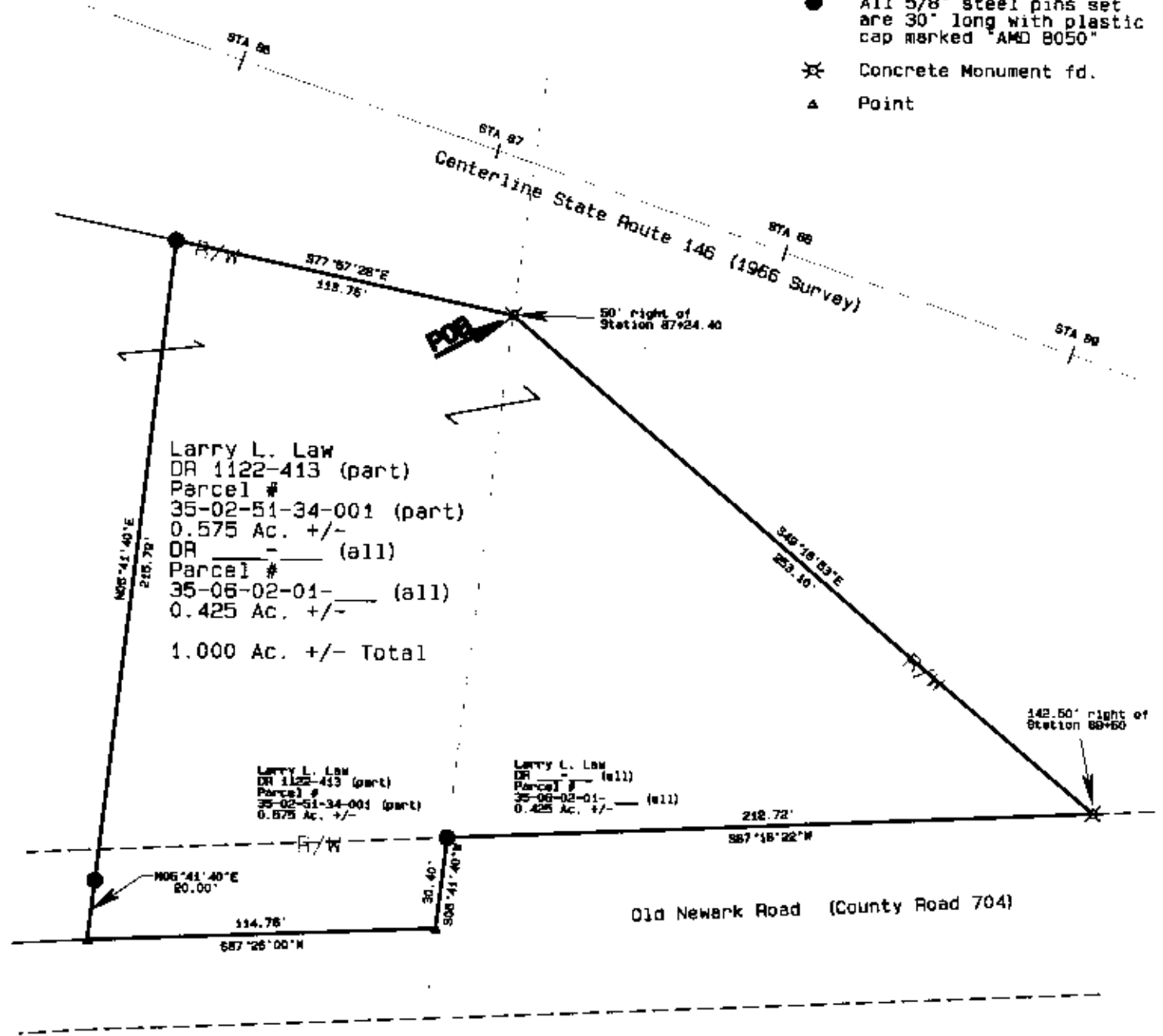
