Situated in Licking Township, Muskingum County, Ohio. Being lot 47 and lot 48 of Cedar Hills Subdivision as recorded in Plat Book 13 Page 52 to 56 of the Muskingum County plat records and being described as follows:

Beginning at an iron pin set in the Southeast corner of lot 23 of Cedar Hills Subdivision;

thence, N.16°54'06"E. a distance of 331.56 feet along the east lines of lots 23, 24, and 25 to a found iron pipe on the South line of Scenic Drive, passing found iron pipes at 100.23', 178.64', and 200.00';

thence, S.84°18'34"E. a distance of 140.18 feet along the south line of Scenic Drive to a found iron pipe;

thence, on a curve to the right an arc distance of 39.28 feet, on a radius of 25.00 feet and whose chord bears S.39°18'36"E. a distance of 35.36 feet along the west side of Lakeview Court to a reset rebar;

thence, S.05°41'24"W. a distance of 128.36 feet along the west side of Lakeview Court to a set rebar;

thence, on a curve to the right an arc distance of 24.89 feet, on a radius of 24.50 feet and whose chord bears S.23°33'41"W. a distance of 24.51 feet along the west side of Lakeview Court to a found iron pipe;

thence, on a curve to the left an arc distance of 43.18 feet, on a radius of 40.00 feet and whose chord bears S.10°25'32"W. a distance of 41.11 feet along the west side of Lakeview Court to a set rebar;

thence, S.69°30'08"W. a distance of 243.75 feet along the North line of lot #46 to the point of beginning.

The above described parcel contains 1.160 acres, more or less, and is subject to all legal easements and right of ways. North is based an assumed meridian. All set rebars are 5/8"x 30" rebars.

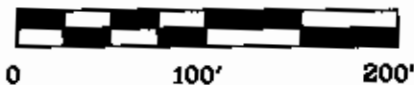

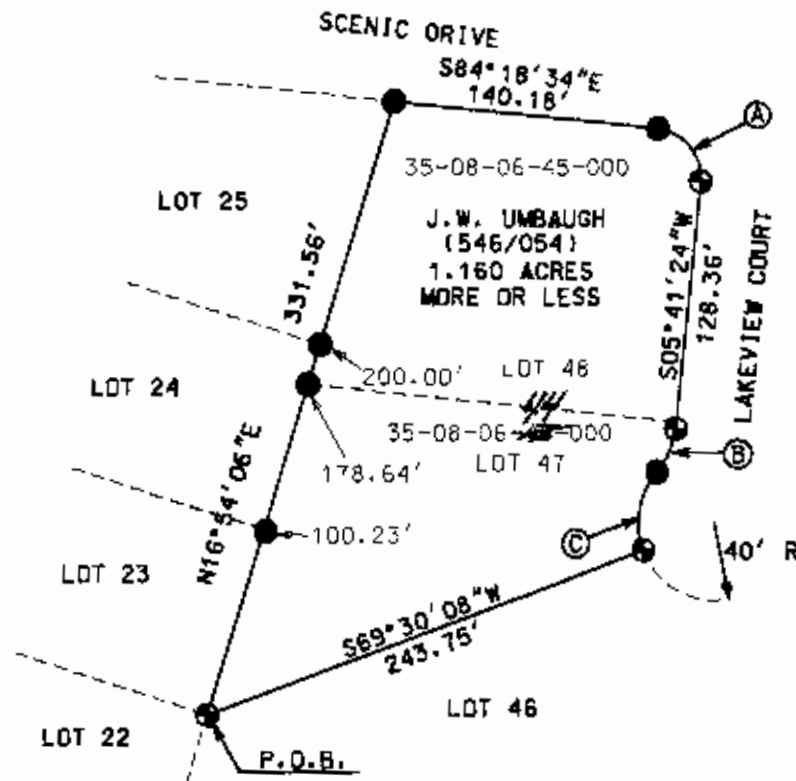
