Saylor and Elizabeth Joy Cameron by a deed recorded in Deed Book 1544, page 89 and passing an iron pin set at a distance of 23.59 feet, a total distance of 363.52 feet to a 5/8 inch rebar found;

thence North 52° 52' 30" West, through the aforementioned Eshelman, Trustees tract, a distance of 171.77 feet to an iron pin set;

thence North 45° 04' 17" East, continuing through said Eshelman, Trustees tract and passing an iron pin set at a distance of 415.54 feet, a total distance of 448.79 feet to the place of beginning.

Containing 1.5727 acres, subject to all legal road right-of-way and any valid and existing easements, restrictions, leases or other conditions of record.
