HEWITT METES & BOUNDS DESCRIPTION

Situated in the State of Ohio, County of Muskingum and Township of Licking and bounded and described as follows:

Being in Section 5, the South half of the 3rd Quarter, T-2N, R-9W, of the U. S. Military Lands and more particularly bounded and described as follows;

Beginning at a point in the Licking-Muskingum County line, said point being the north-west corner of Section 5; thence easterly along the northerly section line of Section 5, a distance of 1320 feet more or less to an iron pin and the true place of beginning for the following described parcel of land;

Thence South 85° 40' 00" East, continuing along the said section line, a distance of 346.98 feet to an existing iron pin in the south-west corner of the Howard Doyle property, (deed reference, Vol. 543, page 817, of the deed records of Muskingum County);

Thence South 85° 41' 47" East, continuing along the said section line, a distance of 942.00 feet to an existing iron pin in the north-west corner of the C. & E. Sidle property, (deed reference, Vol. 431, pages 264 and 450, of the said deed records);

Thence South 3° 27' 48" West, along the westerly property line of the said Sidle property, passing an iron pin at 1126.51 feet, a total distance of 1180.90 feet to a point in the center of Hewitt Road;

Thence along the centerline of Hewitt Road, South 30° 33' 11" West, a distance of 90.00 feet to a point;

Thence along a curve to the right, referenced by a long chord bearing South 70° 30' 29" West, a distance of 81.32 feet to a point;

Thence continuing along the centerline of Hewitt Road, North 84° 19' 21" West a distance of 1120.00 feet to a point in the centerline of Hewitt Road;


Thence along a curve to the right, referenced by a long chord bearing North 47° 56' 02" West, a distance of 96.73 feet to a point;

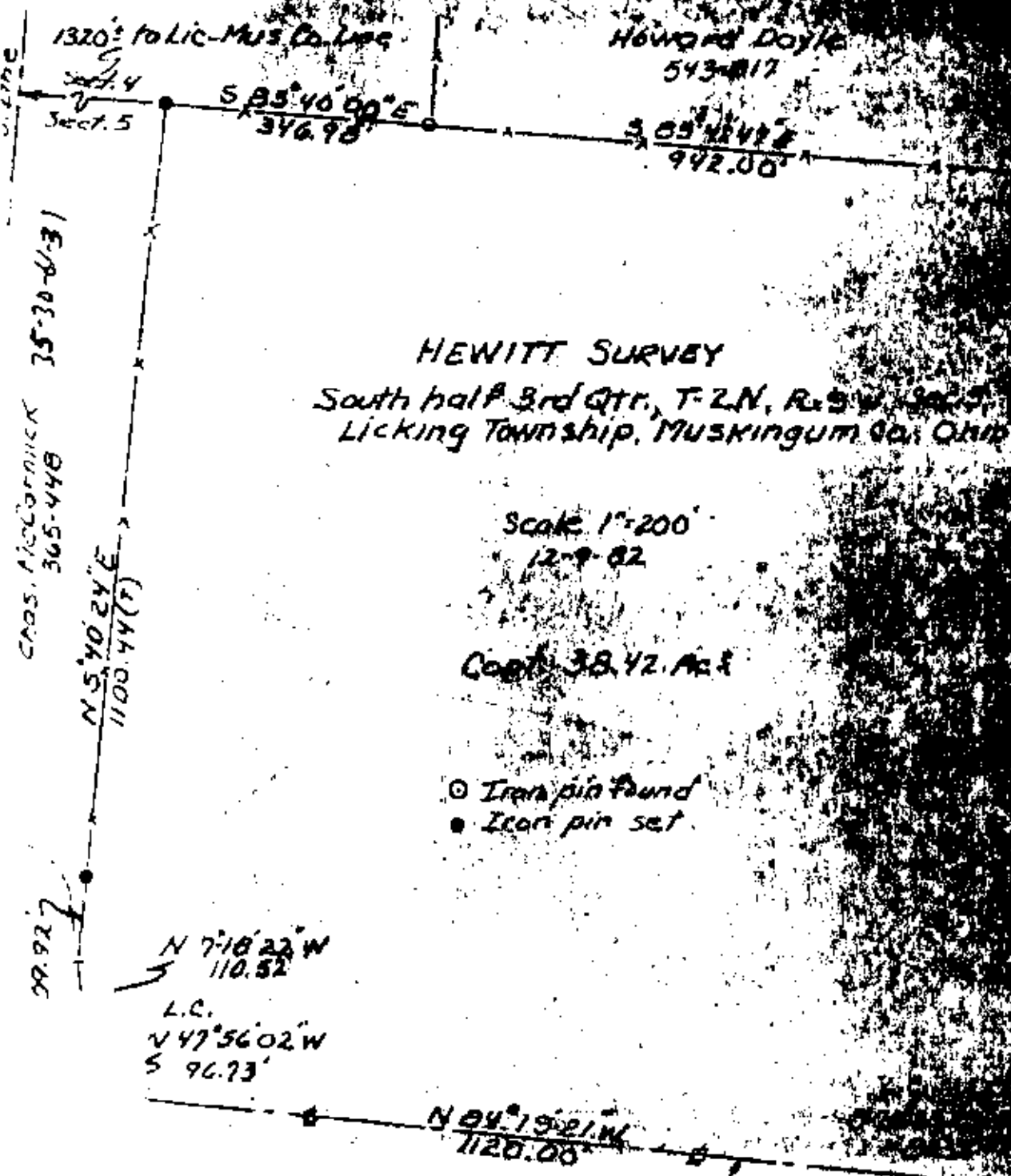
Thence continuing along the centerline of Hewitt Road North 7° 18' 22" West, a distance of 110.52 feet to a point in the centerline of Hewitt Road;

Thence North 5° 40' 24" East, along the easterly property line of the Charles Mc Cormick property, (deed reference Vol. 365, page 448 of said deed records), passing an iron pin at 109.92 feet, a total distance of 1100.44 feet to an iron pin and the true place of beginning.
