

DESCRIPTION

Second Parcel

Situated in the Township of Licking, County of Muskingum,  
and State of Ohio.

Being a part of Lot 7 of Craigs Survey in the south half of  
Quarter Township 3, Township 2, Range 9, United States  
Military Lands, bounded and described as follows:

FIRST TRACT:

Commencing at the northwest corner of Lot 7; thence coincident  
with the north line of Lot 7 N.87°20'31"E. (25.48') to an  
iron pin found and the place of beginning of the following  
described tract; thence extending said line (960.16') to  
an iron pin set at the northwest corner of an (8.104) acre  
tract; thence S.01°42'13"E. (458.20') to an iron pin found  
at the southwest corner of said (8.104) acre tract; thence  
S.09°37'00"W. (1497.92') to the center of Pert Hill Road,  
passing thru an iron pin found at (1422.92'); thence along  
the center of Pert Hill Road the following seven courses:  
(1) N.24°08'50"W. (277.38') to a point, bearing S.59°21'50"W.  
(16.73') from an iron pin set as reference to said point;  
(2) N.33°17'20"W. (100.89') to a point, bearing S.34°34'40"W.  
(19.66') from an iron pin set as reference to said point;  
(3) N.49°05'15"W. (115.91') to a point, bearing S.44°37'20"W.  
(20.20') from an iron pin set as reference to said point;  
(4) N.58°43'20"W. (117.65') to a point, bearing S.22°56'00"W.  
(22.46') from an iron pin set as reference to said point;  
(5) N.70°26'15"W. (90.29') to a point, bearing S.18°34'40"W.  
(23.60') from an iron pin set as reference to said point;  
(6) N.86°39'10"W. (72.54') to a point, bearing S.06°15'10"E.  
(24.07') from an iron pin set as reference to said point;  
(7) S.84°15'25"W. (153.86') to a point;  
thence N.02°15'08"W. (1397.91') to the place of beginning,  
passing thru an iron pin found at (27.92').

Containing (30.856) acres more or less.

Subject to all legal easements and road right of ways.

SECOND TRACT:

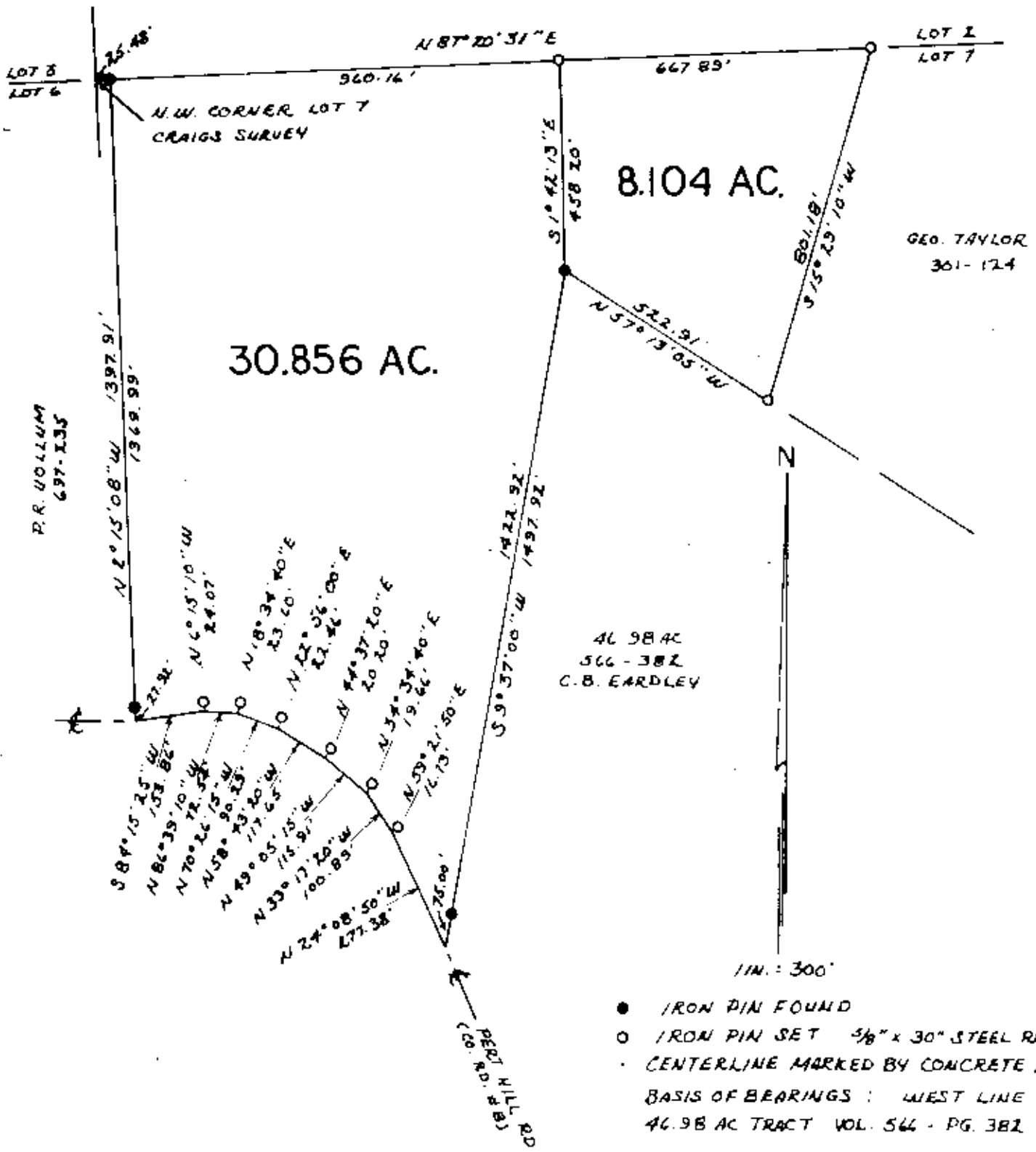
Commencing at the northwest corner of Lot 7; thence coincident

thence S.15°29'10"W. (801.18') to an iron pin set on the north  
line of a (46.98) acre tract as described in Volume 566,  
page 382 of Muskingum County Deed Records; thence N.57°13'05"W.  
(522.91') to an iron pin found at the northwest corner of  
said (46.98) acre tract; thence N.01°42'13"W. (458.20')  
to the place of beginning. Containing (8.104) acres more or  
less.
