

Being a part of Lot number five of a Subdivision of Lands made by Thomas Wells, a plat of said Subdivision being recorded in Volume one, pages 440, 447, and 448 of Muskingum County Deed Records, in the fourth quarter of the 2nd Township in the ninth Range of the United States Military Lands, Licking Township, Muskingum County, Ohio and being further described as follows:

Commencing at the Northwest Corner of said Lot number five, said corner being marked by a wood post; thence South 88 degrees 15 minutes 48 seconds East 119.73 feet to a point marked by an iron pin, said point being the place of beginning of this tract, passing a point marked by an existing iron pin at 104.69 feet; thence continuing South 88 degrees 15 minutes 48 seconds East 771.91 feet to a point marked by an existing iron pin in the center of Township Road number 406, passing points marked by iron pins at 242.85 feet and 587.95 feet; thence South 42 degrees 39 minutes 15 seconds West 111.15 feet to a point in the center of Township Road number 406, thence South 49 degrees 54 minutes 16 seconds West 187.65 feet to a point in the center of Township Road number 406; thence South 50 degrees 53 minutes 16 seconds West 403.47 feet to a point in the center of Township Road number 406; thence South 69 degrees 43 minutes 16 seconds West 258.48 feet to a point in the center of Township Road number 406; thence North 99 degrees 19 minutes 33 seconds East 587.83 feet to the place of beginning, passing points marked by iron pins at 50.86 feet and 271.26 feet.

Containing 6.038 more or less acres, subject to all legal road right-of-ways.

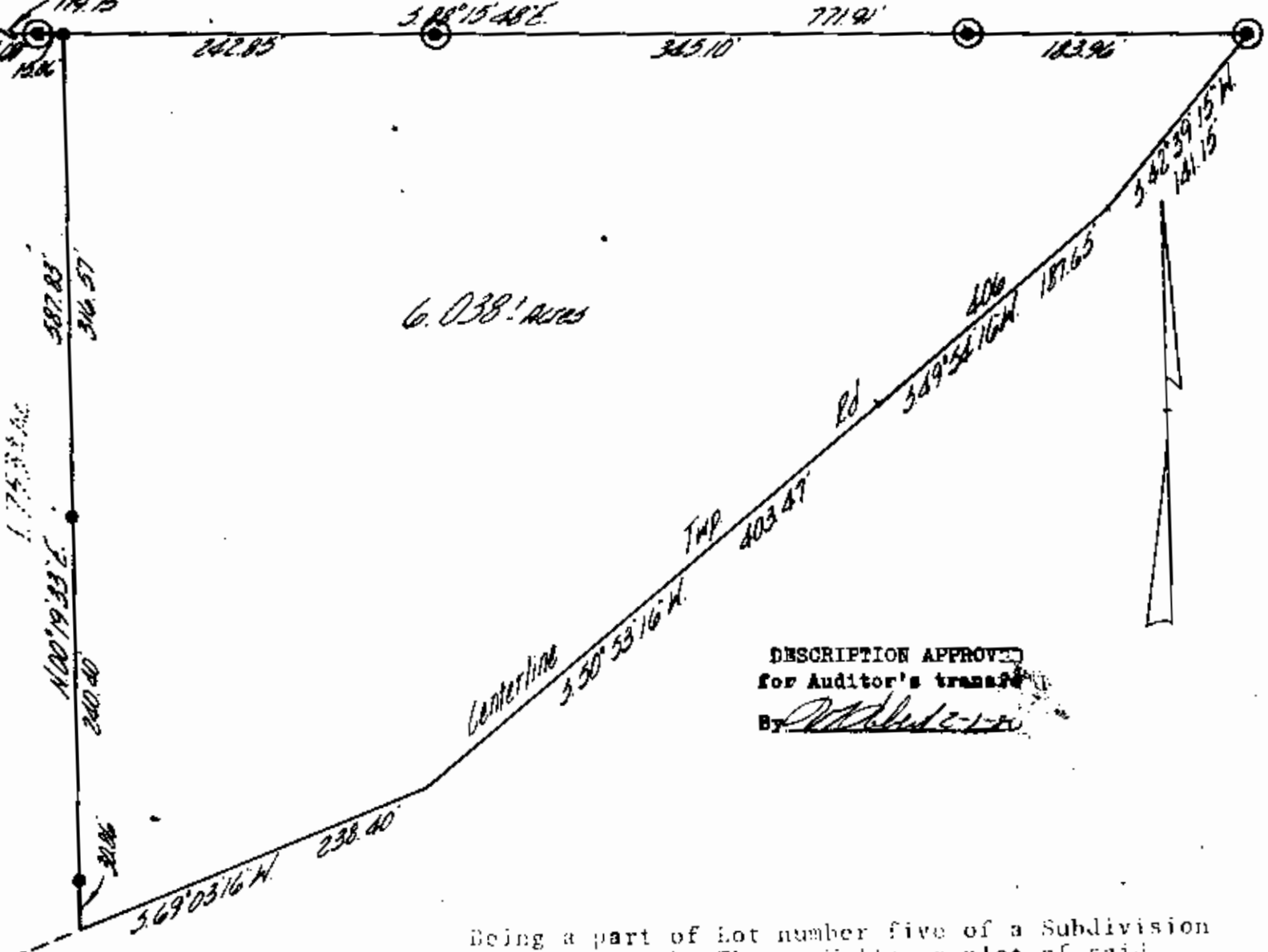
