LEGAL DESCRIPTION

Tract #1

Situated in the State of Ohio, County of Muskingum, Township of Licking, and being part of the south half of Quarter Township 4, Township 2, Range 9, and being part of those lands intended to be described in Deed Volume 726, page 147; being further bounded and described as follows:

Commencing at a stone found at the northeast corner of the south half of Quarter Township 4, thence, north 87 degrees - 31 minutes - 00 seconds west, 286.00 feet to an iron pin found, and the **true point of beginning** for the parcel herein intended to be described;

Thence, south 02 degrees - 29 minutes - 00 seconds west, 211.65 feet along the west line of those lands now or formerly owned by James R. Davis, as recorded in Deed Volume 1090, page 138, to an iron pin set;

Thence, with the new division line through the lands now or formerly owned by Holland & Kathleen Schell, as recorded in Deed Volume 726, page 147, north 22 degrees - 48 minutes - 23 seconds west, 234.08 feet to an iron pin found at the northwest corner thereof;

Thence, south 87 degrees - 31 minutes - 00 seconds east, 100.00 feet along the south line of those lands now or formerly owned by Harlan & Marilyn Davis, as recorded in Deed Volume 1540, page 404, to the **point of beginning**, and **containing 0.243 acres more or less**.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Subject to all legal highways and easements, whether recorded or implied.

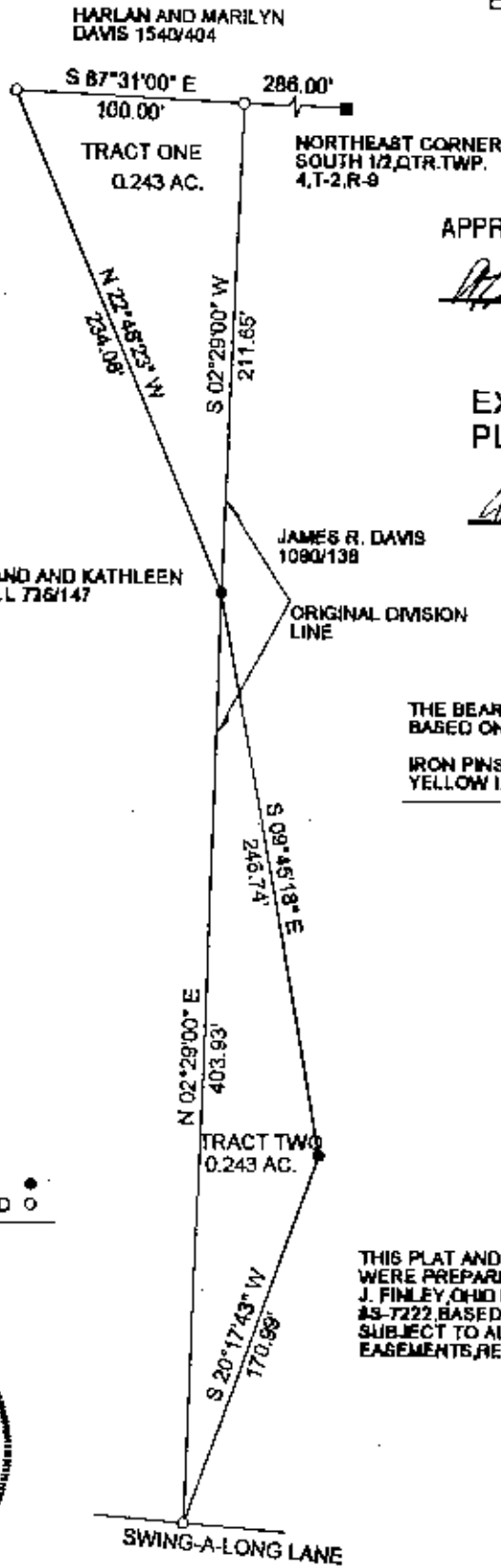
