Thence coincident with the northerly line of the subject parcel and the southerly line of said 1.30 acre Benincasa parcel (reverse L7) South 49°30′57″ East, a distance of 210.54 to a Capped Rebar Set;

Thence the following 2 courses coincident with the westerly line of Poplar Drive:

- 1. (C2) A curve to the left with an arc length of 115.33 feet, a delta angle of 026°42′57", a radius of 247.34 feet, a chord bearing South 24°14′03" West, and chord length of 114.29 feet to a 2 inch diameter pipe found leaning south;
- 2. (L8) South 11°13'31" West, a distance of 58.81 feet to a 1 1/2 inch diameter round bar found on the northeast corner of a 0.59 acre parcel of land now or formerly conveyed to Terry L & Esra Sparks, by a deed recorded in Official Record 2699, Page 3 of the records of the Muskingum County Recorder's Office;

Capped Rebar Set in the above description are 5/8 inch x 30 inch long rebar set with plastic caps marked "UTI BOUNDARY MONUMENT".


