Commencing at the intersection of the centerline of State Route 146 (Station 268+46.80) and the center of Dillon Hills Drive extended (Station 18+47.10); thence along the center of State Route 146 south 40 degrees 45 minutes east 42.80 feet; thence leaving said centerline south 49 degrees 15 minutes west 50 feet to an iron pin found and the true place of beginning of the premises herein intended to be described; thence north 86 degrees 37 minutes west 282.04 feet to a point in Dillon Hills Drive; thence north 3 degrees 23 minutes east 18.0 feet to an iron pin; thence north 17 degrees 10 minutes 40 seconds west 94.34 feet to an iron pin; thence north 35 degrees 39 minutes 24 seconds west 30 feet to an iron pin; thence north 40 degrees 16 minutes 59 seconds west 42.40 feet to an iron pin; thence north 49 degrees 15 minutes east 149.15 feet to a point on the west right of way line of State Route 146; thence along said right of way line south 40 degrees 45 minutes east 368.06 feet to the true place of beginning, containing one and ten hundredths (1.10) acres more or less.

Subject to the easements of Dillon Hills Drive.

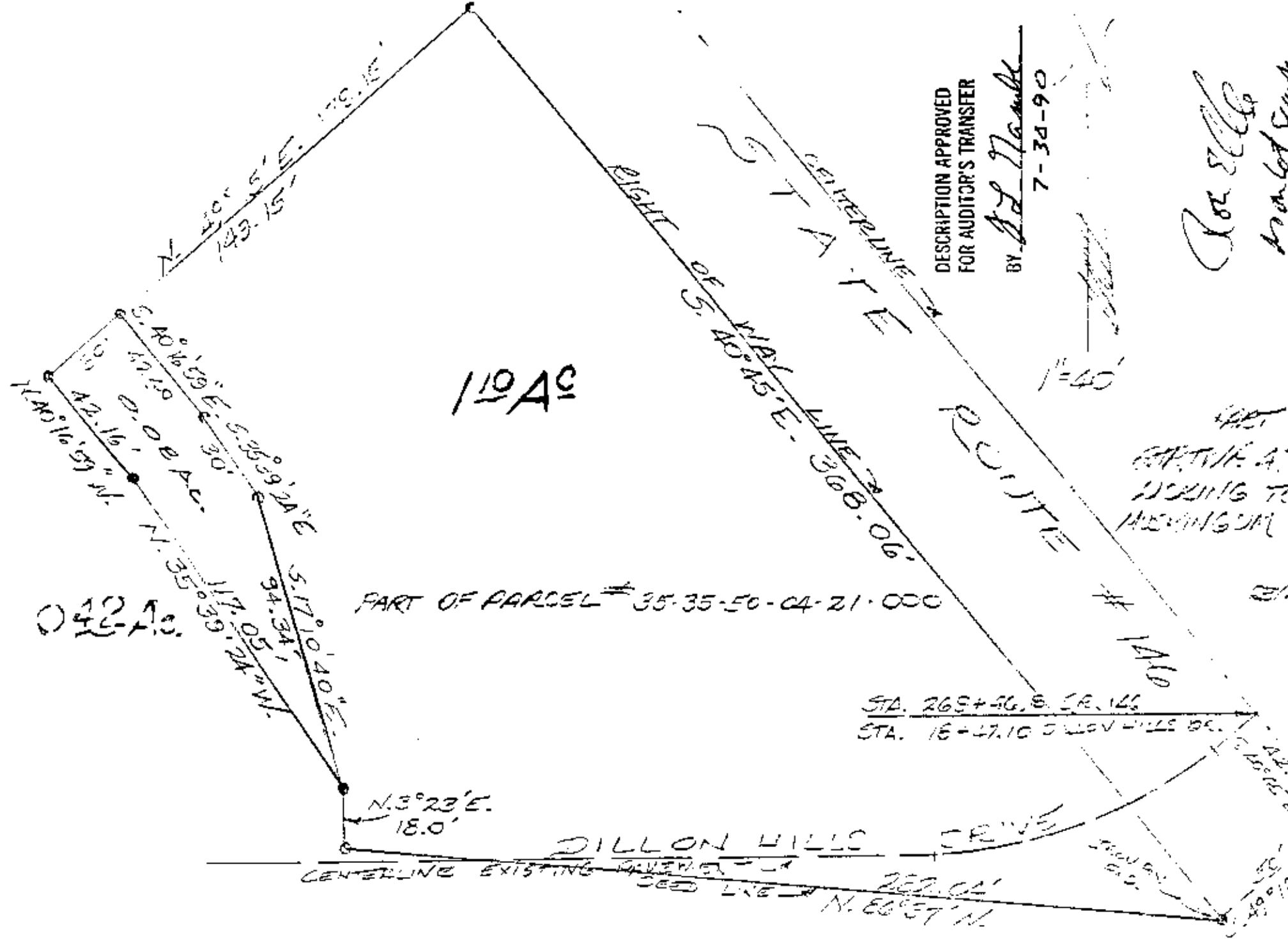
