**BEGINNING** at a 3/4" iron pipe found at the southeast corner of Breezy Heights Subdivision Number 1, recorded in Plat Book 10, Page 15, being the southwest corner of the above referenced 10.00 acre Frazeysburg-Nashport Local School District Board of Education tract;

Thence along the east line of said Breezy Heights Subdivision No. 1, North 14°30'47" East passing 5/8" rebars found at 220.35 feet, at 320.23 feet, at 496.51 feet and pessing a 3/4" iron pipe found with plastic cap inscribed RCT 5892 at 670.22 feet on the southerly right-of-way line of State Route 146, for a total distance of **702.66 feet** to the northwest corner of the above referenced 10.00 acre tract, being a point in the centerline of Newark Road, State Route 146 at Station 297+66.01 as determined from Ohio Department of Transportation Right-of-Way Plan: Muskingum County, S.H. No. 575, SEC. B-C. Said centerline station 297+66.01 equals station 298+86.19 forward for this description based on Right-of-Way plan Station Equation at 297+92.92 back = 299+13.10 forward;

Thence along the centerline of Newark Rd., State Route 146, South 53°08'00"East, passing the intersection of centerline of Clay Littick Drive (County Rd. 708) at 1236.01 feet, for a total distance of 1,336.70 feet to the southeasterly corner of said 10.00 acre tract, at Station 312+22.89 (calculated) (referenced as 312+26.3 by plan) Also passing for reference, 3/4" iron pipes capped RCT 5892 found at station 303+00, 30.00 feet right and 45.00 feet right of centerline, a broken concrete ODOT right-of-way monument found at station 307+00, 45.00 feet right of centerline and a MAG nail found at station 310+00, 45.00 feet right of centerline. Said southeasterly corner being a northerly corner to a 203.12 acre tract (by Auditor's records) conveyed to Wilbur L. Rambo end Betty L. Rembo, Trustees of The Rambo Family Trust, Official Record 1637, Page 190;

Thence leaving the centerline of Newark Rd., State Route 146, along the south line of said 10.00 acre tract, e northerly line of seid 203.12 acre Rambo Family Trust tract, the northerly line of a 2.03 acre tract conveyed to Gerald Alfman (O.R. 1650, Page 305), and along part of the northerly line of a 38.50 acre tract conveyed to James A. Huey and Jean M. Huey (O.R. 2110, Pege 175), North 84°25'05" West crossing the centerline of Cley Littick Drive (Co. Rd. 708) at 117.82', pessing e 3/4" iron pipe with plestic cap inscribed RCT 5892 on the westerly right-of-way line of County Rd. 708 (formerly Township Rd. 47) at 216.10 feet at Station 68+02.74, 80.00 feet right referenced to ODOT Right-of-Way Plan, Muskingum County, Twp. Rd. 47, County Rd. 60, and passing e 3/4" pipe found at 636.03 feet, for e total distance of 1,251.43 feet to the TRUE POINT OF BEGINNING.

**Containing 9.971 acres, more or less**, 1.311 acres within the right-of-way of State Route 146 and County Rd. 708, leaving a net acreege of 8.660 acres.
