

DESCRIPTION OF SURVEY FOR RAYMOND CUMMINS

Situated in the State of Ohio, County of Muskingum, Township of Madison, being part of the First Quarter, Township #3, Range #7 of the U.S. Military District, being more particularly described as follows:

Commencing at an iron pipe at the Northwest corner of said First Quarter (deed); thence along the North line of said First Quarter S 83° 40' 30" E ( 1,601.18 ) feet to a stone ( by deed ); thence leaving the North line of said First Quarter S 15° 56' 19"E ( 8,004.59 ) feet ( by deed ) to the center of County Road #50 ( Stilwell Rd. ), being the place of beginning for the property herein intended to be described; thence along the center of said County Road #50 the following Five courses;

#1- S 84° 47' 02" W ( 157.30 ) feet to a point with an iron pin (set) as an offset N 5° 12' 58" W ( 15.00 ) feet;  
#2- S 78° 23' 09" W ( 627.34 ) feet to a point with an iron pin (set) as an offset N 12° 21' 42" W ( 15.00 ) feet;  
#3- S 77° 38' 18" W ( 499.03 ) feet to a point with an iron pin (set) as an offset N 12° 21' 42" W ( 15.00 ) feet;  
#4- S 72° 28' 47" W ( 107.58 ) feet to a nail (found);  
#5- S 61° 19' 16" W ( 135.71 ) feet; thence leaving the center of said County Rd. #50 N 18° 14' 04" W ( 49.57 ) feet to the South bank of the Muskingum River; thence along said South bank the following Five courses;

#1- N 56° 17' 23" E ( 444.71 ) feet;  
#2- N 68° 38' 21" E ( 220.12 ) feet;  
#3- N 73° 34' 51" E ( 299.11 ) feet;  
#4- N 75° 40' 49" E ( 99.00 ) feet;  
#5- S 86° 55' 00" E ( 505.90 ) feet to the West line of the property as described in Deed Book 906, Page 327 of said County's Records; thence leaving said South bank and along the West line of said Deed reference S 16° 29' 04" E ( 115.70 ) feet to the place of beginning, passing through an iron pin (found) at ( 100.70 ) feet, containing ( 5.579 acres.

The bearings within this description are based on the West line of the property described in Deed Book 906, Page 327 as surveyed by J. Spilker R.S. #5862.

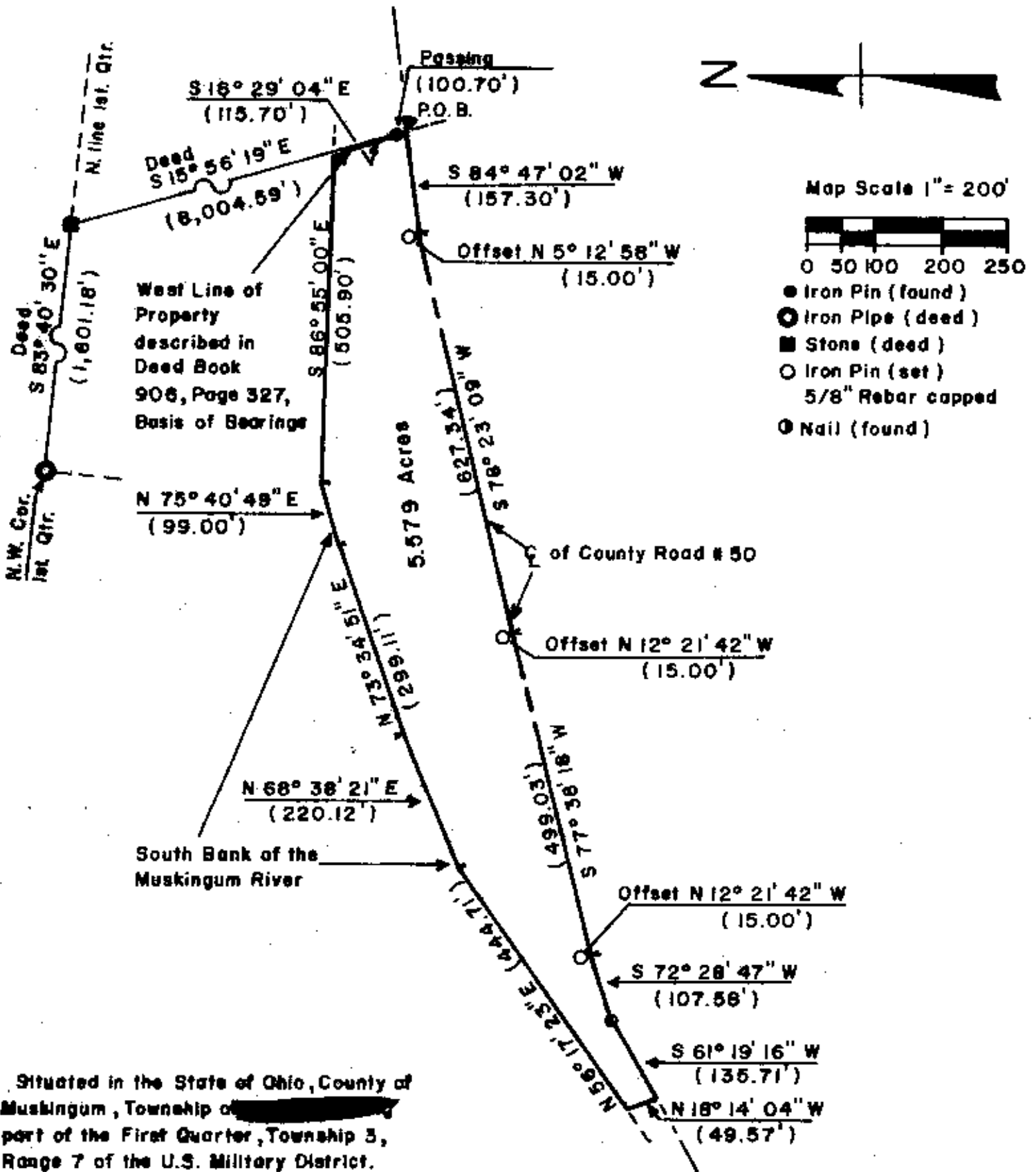
The above description is intended to describe all of the property contained in the prior deed reference Deed Book 848, Page 67, of said County's records.
