

Re-Survey of Neal Arthur Hawk Lands in Madison Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Madison, and being part of Quarter Township 3, Township 3, Range 7, United States Military Lands, and being all the lands presently owned by Neal Arthur Hawk as per Official Record 1700, Page 902, and being more particularly described as follows:

Beginning for reference at an iron pin found at the northeast corner of Lot 7 of Rolling Meadows No. 1, (Plat File 1, Page 140);

Thence North 01 degrees 16 minutes 43 seconds West, 1670.62 feet to point in the centerline of North River Road East, (St. Rte. 666, R\W 60'), and the principal place of beginning;

Thence along the east lines of Michael and Cathy Nichols, (DR 1110-601), Linda J. and Dwight P. Kelly, (OR 2621-57), and Craig Myers and Linda McDonald, (OR 1719-289), North 01 degrees 25 minutes 48 seconds East, 2016.35 feet to an iron pin set, passing iron pins found at 29.52 feet, 443.73 feet, 796.95 feet, and 2013.35 feet;

Thence along the north line of said Myers, and McDonald lands, North 89 degrees 03 minutes 24 seconds West, 548.21 feet to an aluminum monument found, on the east line of lands presently owned by the State of Ohio, Department of Natural Resources, (OR 1511-231);

Thence along the east line of said State lands, North 02 degrees 00 minutes 16 seconds East, 2165.38 feet, to an aluminum monument found, passing an iron pin found, with aluminum cap, at 2.98 feet, and 0.22 feet perpendicular offline to the west;

Thence along a south line of said State lands, South 88 degrees 09 minutes 58 seconds East, 2709.74 feet to an iron pin found in Copeland Woods Road, (Twp. Rd. 157, R\W 40'), passing an iron pins found with aluminum caps at 3.14 feet, and 0.23 feet perpendicular offline to the north, and 13.03 feet, and 0.19 feet perpendicular offline to the north, and passing an iron pin found at 2684.70 feet;

Thence along and in said Copeland Woods Road, South 01 degrees 43 minutes 33 seconds West, 1767.42 feet to an iron pin found on the northwest corner of lands presently owned by Dwight L. Minner Jr., (DR 1118-545), passing an iron pin found at 1222.74 feet and 0.32 feet perpendicular offline to the west, and being the northwest corner of lands presently owned by Johnathan M. and Loretta N. Hersherberger, (OR 2725-757);

Thence along the west line of said Minner lands, South 01 degrees 23 minutes 40 seconds West, 2198.39 feet to a point in the centerline of Mollies Rock Road, passing an iron pin found at 2178.18 feet;

Thence along the centerline of said road the following nine courses:

- 1.) Along a curve to the right, with a delta angle of 7 degrees 14 minutes 07 seconds, a radius of 473.01 feet, an arc length of 59.73 feet, and a chord which bears North 86 degrees 25 minutes 12 seconds West, 59.69 feet;
- 2.) North 83 degrees 26 minutes 13 seconds West, 261.48 feet to a point;
- 3.) North 84 degrees 28 minutes 21 seconds West, 217.47 feet to a point, from which an iron pin found bears North 05 degrees 31 minutes 39 seconds East, 25.30 feet;
- 4.) North 84 degrees 28 minutes 21 seconds West, 91.67 feet to a point;
- 5.) Along a curve to the left, with a delta angle of 15 degrees 20 minutes 01 seconds, a Radius of 546.48 feet, an arc length of 146.25 feet, and a chord which bears South 88 degrees 15 minutes
