DEED DESCRIPTION 57.5953 ACRES +/- OR 2,508,850 Sq. Ft.

BEING A SURVEY OF PART OF PARCEL \$2, 3, 4, AND 5 OF THE PARCEL CONVEYED TO FLORENCE SKAGGS ETAL. AS FOUND IN DEED VOLUME 1046 PAGE 217, IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, AND BEING AUDITOR'S PARCEL NUMBERS 38-38-70-21-03-001, 38-38-70-21-17-000, 38-38-70-21-20-000, AND 38-38-70-21-21-000 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF MADISON, AND BEING A PART OF SECTION \$21, TOWNSHIP 3, RANGE 7, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING, FOR REFERENCE, AT A RAILROAD SPIKE SET MARKING THE CENTER OF SECTION 21 BEING IN THE CENTERLINE OF STEEL HILL ROAD (C.R. 114), SAID SPIKE BEING REFERENCED BY AN IRON PIN POUND N 84°22'26" W 17.52 FEBT, AND BEING THE SOUTHWEST CORNER OF TRACT 4 OF THE SKAGGS TRACT AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT MEREIN TO BE DESCRIBED:

THENCE, WITH THE MID LINE OF SECTION 21 AND THE EAST LINE OF A PARCEL CONVEYED TO DAVID D. MOCK, AS RECORDED IN DEED VOL. 1060, PAGE 150 N 05'35'27" E 1060.21 FEET TO AN IRON PIN SET;

THENCE, LEAVING SAID MID LINE, BUT REMAINING WITH THE WEST LINE OF THE MOCK TRACT, N 32°21'11" W 355.22 FEET TO AN IRON PIN FOUND ON THE SOUTH LINE OF A PARCEL CONVEYED TO JAMES C. & SUSAN C. HARPER AS FOUND IN DEED VOL. 1110, PAGE 260;

THENCE WITH THE SOUTH LINE OF THE SENSABAUGH TRACT S 84'04'50"

THENCE WITH THE NORTH LINE THE MUSKINGUM MINING CO. TRACT N 94'24'18" W 1346.17 FEET TO AN IRON PIN SET IN THE MID LINE OF SECTION 21;

THENCE WITH THE MID LINE OF SECTION 21, N 05'35'27" E 511.38 FEET TO THE PLACE OF BEGINNING AND CONTAINING 57.5953 ACRES OR 2,508,850 SQ. FT., MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS OF RECORD.
