Situated in the Quarter Township #1, T-2-N, R-7-W, U.S.M.L., Madison Township, Muskingum County, Ohio. Being the lands of Frank Kachilla as conveyed in parcels 2 and 3 of Deed Book 1017 page 285 of the Muskingum County deed records and being described as follows:

Commencing at a stone found marking the Southeast corner of west half of quarter township 1; thence, S.89°11'28"W. a distance of 2,176.26 feet along the North line of Washington township to a found iron pipe on the Southwest corner of the lands, now or formerly, owned by T. Hittle (1088/113), **BEING THE POINT OF BEGINNING;**

thence, S.89°49'56"W. a distance of 2,322.09 feet along the north line of Washington Township to a set rebar;

thence, N.00°26'10"E. a distance of 792.00 feet to a set rebar on the North side of Church Hill road;

thence, N.36°09'15"E. a distance of 462.00 feet through said road right of way to a point in the center of said road;

thence, N.26°24'18"E. a distance of 924.00 feet through said road right of way to a point in the center of said road;

thence, N.05°16'01"E. a distance of 376.72 feet through said road right of way to a point in the center of said road on the south line of the lands, now or formerly, owned by the Muskingum Mining Company;

thence, N.89°45'29"E. a distance of 1,569.53 feet along the south line of said Mining lands, and along the south line of the lands, now or formerly, owned by C. & B. Baker (539/914) to a found iron pin on the Northwest corner of the lands owned by T. Hittle (1088/113), passing a set rebar at 23.00 feet, and passing a stone found on the Southwest corner of said Baker lands at 1,505.04 feet;

thence, S.00°41'21"E. a distance of 2,367.74 feet along the west line of said Hittle lands to the point of beginning

The above described parcel contains 108.831 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based an assumed meridian.

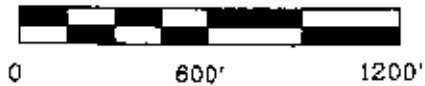

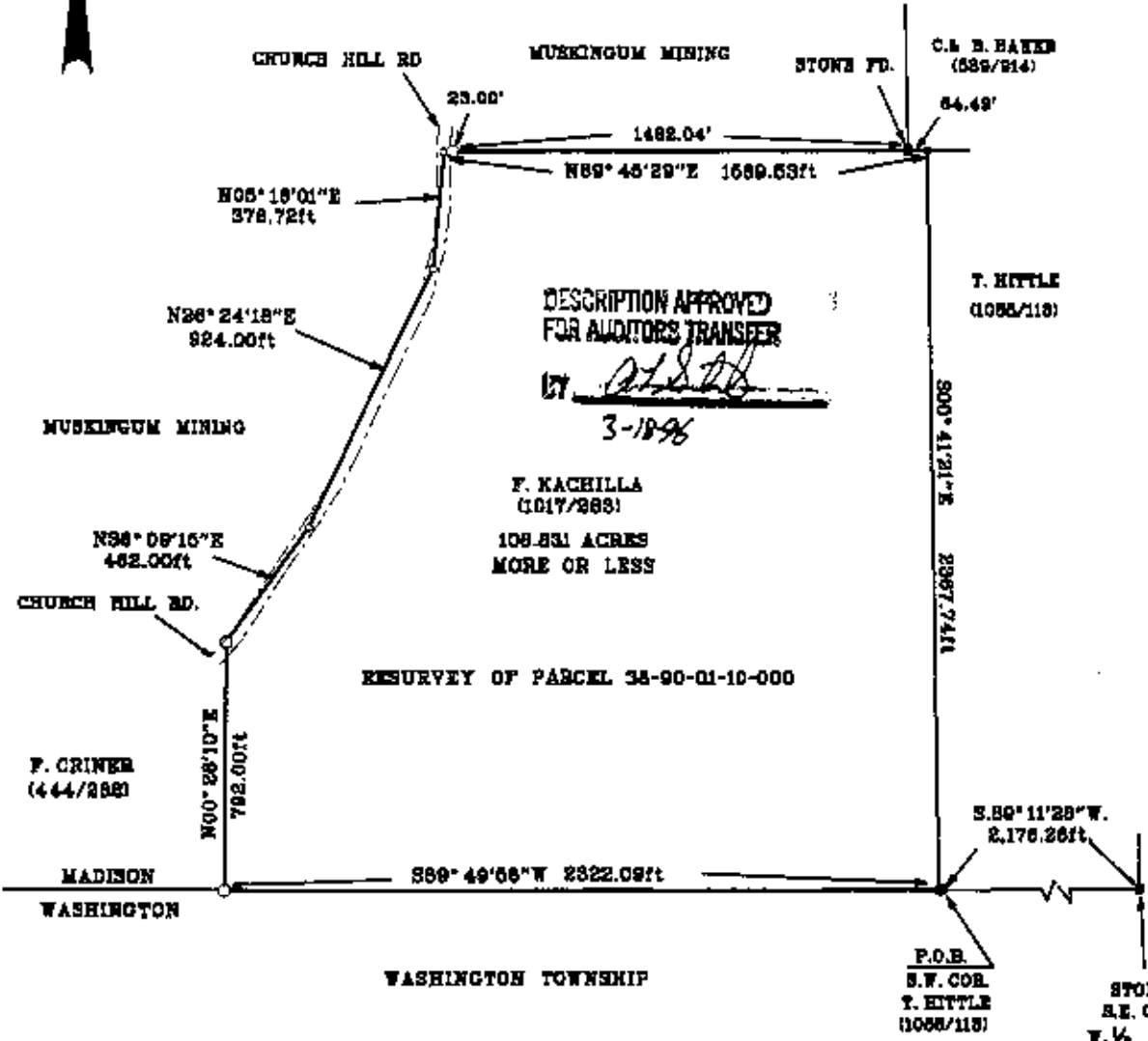
