**SURVEY DESCRIPTION

Situated in the West half of Quarter Township 1, T-2-N, R-7-W, U.S.M.L., Madison Township, Muskingum County, Ohio. Being part of the lands of T. & J. Hittle as conveyed in Deed Book 1088 page 113 of The Muskingum County Deed Records and being described as follows:

Commencing at the Southeast corner of the West half of Quarter Township 1; thence, S.89°11'28"W. a distance of 641.89 feet along the South line of said quarter township to a point; thence, N.00°06'41"E. a distance of 429.21 feet to a found iron pin marking the common corner of L. Hittle (661/027), P. Girton (1026/282) and T. & J. Hittle (1088/113), BEING THE POINT OF BEGINNING;

thence, S.78°44'35"W. a distance of 201.81 feet along the north of the lands of L. M. Hittle (661/027) to a point;

thence, N.09°55'27"E. a distance of 133.88 feet through the lands of T.& J. Hittle (1088/113) to a set reber;

thence, N.74°55'14"E. a distance of 167.30 feet through said Hittle lands to a found iron pipe on the common corner of P. Hittle (1084/158) and on the west line of P. Girton (1026/282);

thence, S.05°35'32"E. a distance of 136.66 feet along said Girton lands to the point of beginning.

The above described parcel contains 0.548 acres, more or less, and is subject to all legal easements and right of ways. North is based an assumed meridian. All set rebars are 5/8"x 30" rebars.

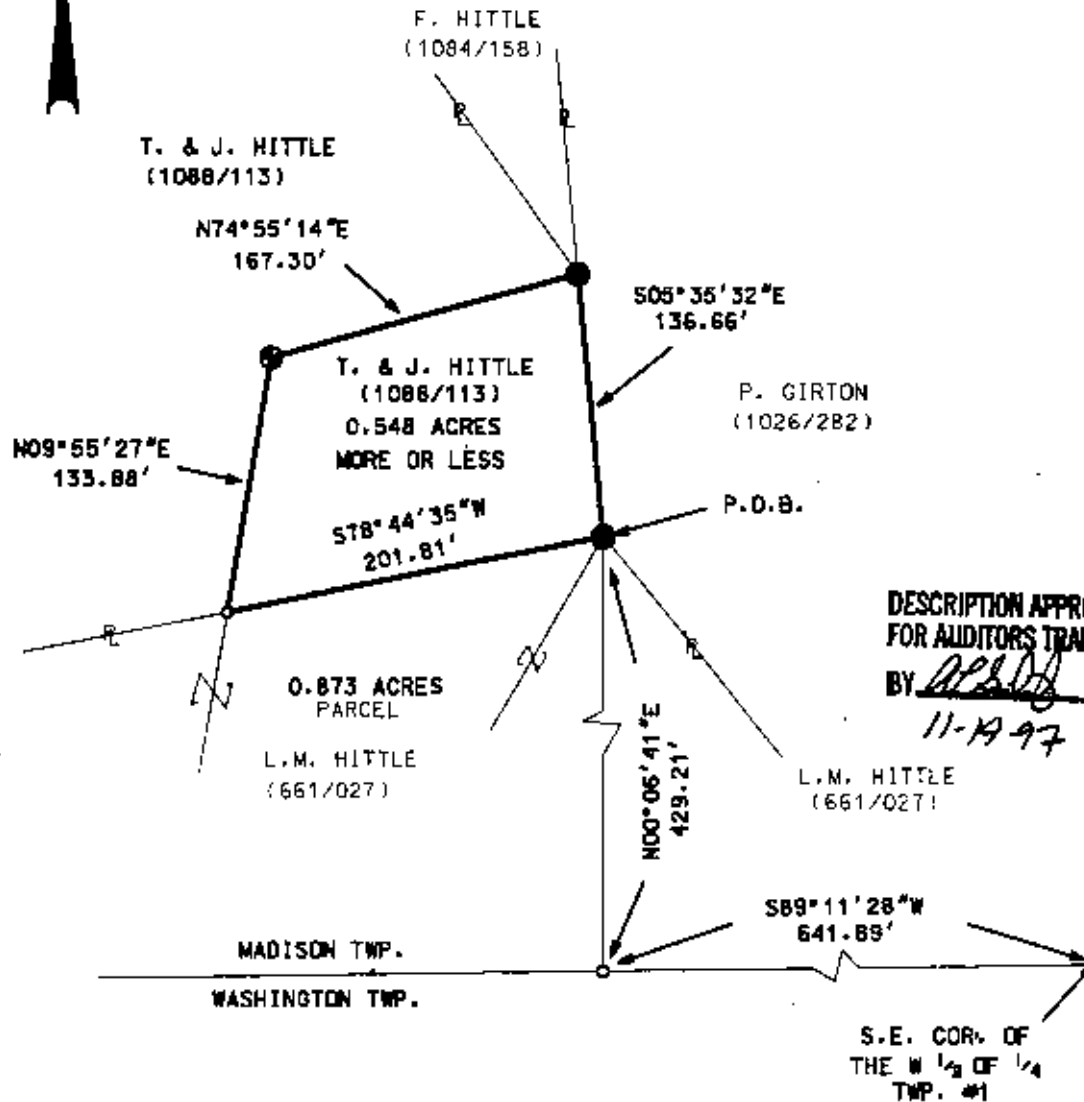
NORTH IS BASED UPON
