

AUDITORS PARCEL 38-90-01-18-000 66.06 Acres


Situated in Quarter Township 1, T-2-N, R**-**7-₩, U.S.M.L., Madison Township, Muskingum County, Ohio.

Commencing at a stone found marking the Southwest corner of the East half of Quarter Township 1; Thence, N.01°22'55"E. a distance of 2,348.85 feet along the West line of the East half of Quarter Township 1 to a found iron pin on the Northwest corner of the lands of W. Hughes (958/229), and BEING THE POINT OF BEGINNING;


- Thence, S.88°26'05"E. a distance of 394.31 feet along the North line of said Hughes lands to a point in the center of Mutton Ridge Road, passing a found iron pin at 377.66';
- Thence, N.01°34'02"E. a distance of 185.67 feet along said road to a point;
- Thence, N.10°03'44"W. a distance of 343.10 feet along said road to a point;
- Thence, N.06°52'01"W. a distance of 715.76 feet along said road to a point;
- Thence, N.03°12'02"W. a distance of 192.01 feet along said road to a point on the Southeast corner of the lands of D. & M. Merriam (1922/348);
- Thence, N.87°38'55"W. a distance of 245.65 feet along said Merriam lands to a found iron pin, passing a found iron pin at 30.00';
- Thence, S.47°54'11"W. a distance of 101.51 feet along said Merriam lands to a found iron pin;
- Thence, N.87°35'04"W. a distance of 853.10 feet along said Merriam lands to a found iron pin on the eastern line of the lands of The State of Ohio, Department of Natural Resources (1511/231);
- Thence, **S.67°23'12"W.** a distance of **1,099.94** feet along said State lands to a found aluminum monument;
- Thence, S.01°36'54"W. a distance of 903.34 feet along said State lands to a stone found on the North line of the lands of B. Woerner (1124/545);
- Thence, N.87°08'07"E. a distance of 63.89 feet along said Woerner lands to a found iron pin on the Northwest corner of the lands of J. Hohman (1508/146);
- Thence, S.87°53'27"E. a distance of 1,908.51 feet along said Hohman lands and the lands of W. Hughes (1068/587) to the point of beginning.

The above described parcel contains 66.06 acres, more or less and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic. D. caps. North is based upon an assumed meridian. Description was approve from an actual field survey by Bowman


