SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF MEIGS, AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 20, TOWNSHIP 12, RANGE 11 OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1096, PAGE 351; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

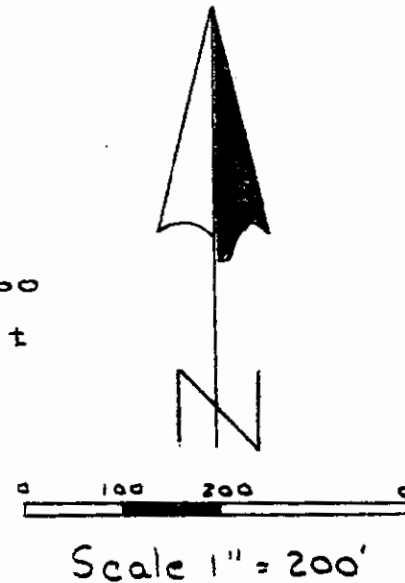

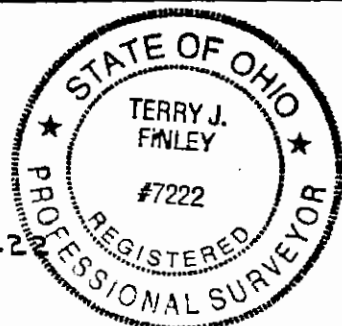
